Friday, March 21, 1975

The Senate of the Eighth Legislature of the State of Hawaii, Regular Session of 1975, convened at 11:30 o'clock a.m., with the Vice-President in the Chair.

The Divine Blessing was invoked by Mrs. Healani A. Tracy of the Baha'i Faith, after which the Roll was called showing all Senators present with the exception of Senators Hara, Henderson and Ushijima who were excused.

The Vice-President announced that the President had read and approved the Journal of the Forty-Sixth Day.
