Senator Ching then rose on a point of personal privilege, both as an individual Senator and as Majority Leader, and stated as follows:

"Mr. President, I rise on a point of personal privilege.

On Monday morning, March 24th, there appeared in the Honolulu Advertiser a commentary written by one of the researchers in the Senate Minority Office.

I do not contest that individual's right to write letters to the newspaper, but considering that he appears to be the voice of the Minority in the Senate, I rise to rebut the content of the commentary to make it very clear that there are many of us who do not agree or subscribe to its allegations.

His complaint simply stated that the Democratic committee chairmen are not reporting Republican measures out of their committees, that certain content of Republican bills are being transposed into Democratic bills for passage, or that entire Republican bills are being reported out of Committee under the number of a bill introduced by a Majority member.

First, let me state clearly that the responsibility of the Majority in the Legislature is to act maturely and cohesively to produce the programs and legislation necessary to move the State forward. If this is done correctly and completely, then the Majority may take the credit for it. If it is done improperly, and if legislation does not move the programs of the State forward, then the Majority is criticized.

And, of course, that criticism comes from the 'loyal opposition', who now seem to desire to be part of the Majority.

We have never in this Body, either in committee or on the floor, limited Minority input or stifled Minority ideas; nor is it our intent ever to do so. The loyal opposition must serve its purpose.

However, we must retain the integrity and responsibility of our committee chairmen; and those committee chairmen are the best judges of the method

in which ideas, concepts, or bills should move to the floor for a vote. If a committee chairman believes that simply because a bill has been introduced by a certain Senator, whether that Senator be Minority or Majority, that it stands a chance to be defeated on the floor, then it is for that chairman and his committee to incorporate the general ideas of that legislation in some other vehicle which will pass if brought to the floor.

The newspaper article referred to alleged specific instances where chairmen of committees have either failed to move Republican measures or have incorporated certain Republican ideas in Democratic bills. I will not take the time to rebut each of those individual allegations.

However, in general, it is my observation that our committee chairmen have in each instance acted responsibly and have utilized Minority input to the benefit of the State, where that input would benefit the State; or have rejected it, where it would not.

The attempt by the Minority to say that we have somehow failed to provide openness in government or reform, in this instance, is fallacious. Open consideration of Minority ideas has been the keynote of this session, and the commentary in Monday's Advertiser is unwarranted and without basis."

Senator Rohlfing then rose and spoke as follows:

"I rise on a point of personal privilege, Mr. President. I do not have the article before me, and I do not contest all of the statements made by the distinguished Majority Leader from the point of view of his position as Majority Leader.

I think the fundamental point that he brought up, however, is one with which we concur regardless of our viewpoint as to particular aspects of any piece of literature in the paper. And that is that we are looking with maturity at the issues and the bills facing us in our committees. That maturity should come within the framework of what the people of the State of Hawaii expect of us as individuals regardless of what Party we belong to; because today the public is not concerned so much with what label you wear, but where you stand, what your responsibility is, and whether you are maturely looking at the merits

of the legislation and the concerns of the people.

By the polls, the party to which those of us on this side of the isle belong represents something like 18% of the people of this nation. The Democratic Party to which you belong across the aisle represents a lot more by percentage polling. But what is significant is that the change in memberships of political parties has gone from both parties to a category called Independent, which today is the dominant political affiliation of the people, certainly of Hawaii and in most of the United States.

When we are in this Body, because of our peculiar and multiple representation system, we represent the same people regardless of whether we wear the Democratic or Republican label. And so in representing those people, we should do so on the basis of cooperative effort. If not, then we should change the system and have one representative and get it down to a much more functional representation system.

The people of Hawaii have not wanted that. They did not want it in the Constitutional Convention. They wanted to continue the system whereby we can get over the partisanship and get on with mature consideration of the legislation before us.

What particularly concerns those of us on this side of the aisle, however, is that continuous repetition of statements seem to be popping up in the press that the members of the House of Representatives have been informed that no Republican bills will pass the Senate, and that there will be no resolutions, etc., coming out of the Senate; and that is why they should not pass Republican bills or even include Republican measures within legislative vehicles that have gone over to the other side.

If this is true, then I think we have defeated the very thing that the Majority Leader said, and that is that we were here to consider things on the basis of maturity. And if that is not true, then I hope his statement here that it's the Committee Chairman's responsibility to make that decision, to review the legislation, to review the proposals or input that the Minority has, or more particularly that each individual Senator has, because we don't always agree amongst ourselves.

And while we feel that the Majority Party certainly has a role of responsibility

to the people of this State, each member of this Body has that same responsibility; and he's going to have it for three and a half more years. If we can't get together and work constructively in the spirit of the cooperation that was enunciated on the first day of this session, then we are all going to have 'shame' on our faces.

Thank you, Mr. President."
