Senator King then rose to speak against the bill as follows:

"Mr. President, I rise to speak against the motion.

This is a bill that is going to raise our gasoline tax by  $3\frac{1}{2}$  cents. What we are being asked to do is to bail out a department that has proceeded with poor planning in the planning of our highways.

We are being put into a box; and because at the present time the payment on debt service on the highway funds is close to fifty percent of that fund, and by the end of six years we'll be approaching close to seventy percent, we are asked to come in and help out by this 3½ cent increase in our gasoline tax.

If mine were the sole vote that would decide this matter, I would have to think very carefully about it because if we didn't do this, they would have a problem in terms of paying off this debt service that has risen so high at the present time. But what we have done is to once again do it in a very regressive fashion.

We haven't yet provided adequate mass transit; so, therefore, people have to use their cars. To impose this  $3\frac{1}{2}$  cent increase in our gasoline tax will once again hit the hardest those with the lowest income. We could have done it another way. Of course, we could even use the State general fund money to pay this. This unfortunately would take away the reimbursable quality of these general obligation bonds, and they would be counted against the State's debt ceiling.

What we could have done, however, and as I had suggested earlier, would have been to impose a ten percent tax on occupied hotel rooms. This would have raised \$30 million plus a year, and the rationale for this could have been that the tourists use the roads as well so that a percentage of that ten percent could have been applied to this.

Because we have been put into a box, because we're asked to bail out planning mistakes while we plunged ahead with highway construction, and because this is once again regressive, I speak against it, Mr. President.

Thank you."

Senator R. Wong then rose and spoke in favor of the bill as follows:

"Mr. President, I rise to speak in favor of this bill. It will increase the tax on liquid fuel for highway use by  $3\frac{1}{2}$  cents per gallon. It's important, Mr. President, that the increase will become effective on May 1, 1975 and remain in effect until June 30, 1976.

The additional revenues from this bill will provide enough funds to preclude the incurring of an operating deficit in the highway special fund. Also, Mr. President, passage of this will keep to a nominal level -about \$12 million -- the amount of bonds authorized for highway projects which will be counted toward the State's debt ceiling next year. This liability against the debt ceiling will be for one year only.

This bill is by no means an adequate or permanent solution to the problem of financing our highway special fund. We are faced with a levelingoff of fuel consumption and a rapid increase in many fixed costs in the highway programs, particularly the debt service costs for highway projects. New sources of revenue need to be investigated, and we must be critical in our review of future projects.

The Department of Transportation has reported that it will undertake a comprehensive analysis of revenues and expenditures related to surface transportation and will submit its analysis and recommendations to the 1976 Legislature. This information should provide a solid base for the Legislature to seek a more permanent solution to the highway special fund problem during the next session.

Mr. President, I urge the members of the Senate to vote in favor of this bill.

I would like to point out to the members of this Body and for the record, and this is contained in Standing Committee Report No. 893 which was passed out by the Committee on Judiciary with all twelve members signing without any reservations, that the amendment put on by the Senate to the House Draft is found on page 2 thereof.

It is a relatively simple amendment which in effect changes the duty of the bank to make readily available to depositors at each of its branch offices the rules and regulations dealing with the use of the passbook. This simple procedure was changed so that the depositors would have to be given these instructions, rules, that have to do with savings accounts at the time of the application for a savings passbook. My understanding, having served on the Committee, is that this was the only amendment that was tacked on to this bill.

Again, looking at my copy of the bill, I notice that there are only two pertinent sections of the bill. In Section 1, there is an amendment to Section 403-123, Hawaii Revised Statutes; and Section 2 involves Section 403-124, Hawaii Revised Statutes. Chapter 403, to which these two sections belong, is commonly known as The Hawaii Bank Act.

That is the way the bill goes over. Sections 3 and 4 of the bill are merely for the Revisor of Statutes and the effective date of the bill.

I do want to place these remarks in the record, Mr. President, because I understand that there will be some changes that are contemplated by the august Body across the way. So I thought that the record should be protected as this bill left this Body today.

Thank you very much."

Senator Rohlfing then stated as follows:

"Mr. President, in looking at this bill, I find that it is a very minor amendment and that the amendment is really of no consequence to anyone.

On the original version, it was very clear that a depositor had the right to look at the rules and regulations of the particular banking institution. I wonder, then, what real value this amendment is going to have. I think we are really dealing with a frivolous amendment in this situation.

As Senator Ching has indicated, there may be some other motivations involved here; and I, for one, will vote No on this bill."

The motion was put by the Chair and carried and H.B. No. 1597, H.D. 1, S.D. 1, entitled: "A BILL FOR AN ACT RELATING TO BANKING", having been read throughout, passed Third Reading on the following showing of Ayes and Noes:

Ayes, 23. Noes, 1 (Rohlfing). Excused, 1 (Kawasaki).

At this time, Senator Hara, Chairman of the Committee on Education, requested a waiver of the 48-hour notice of a Public Hearing on Governor's Message Nos. 114 to 122 and 218 to 221; and the President granted the waiver.

Senator Anderson then rose on a point of personal privilege and requested that the Chair grant fewer waivers to the Rules due to the busy schedules during the last days of the session. Senator Anderson remarked that it becomes difficult to schedule and plan with many waivers and exceptions to the rule.

The President replied that he will be very careful in issuing these waivers and assured Senator Anderson that due consideration will be given concerning scheduling in the next week.

#### ADJOURNMENT

At 1:51 o'clock p.m., on motion by Senator Taira, seconded by Senator Anderson and carried, the Senate adjourned until 11:30 o'clock a.m., Monday, April 7, 1975.
