

## FIFTY-SIXTH DAY

Monday, April 7, 1975

The Senate of the Eighth Legislature of the State of Hawaii, Regular Session of 1975, convened at 11:30 o'clock a.m., with the President in the Chair.

The Divine Blessing was invoked by the Reverend Mel Walter of the First Baptist Church, after which the Roll was called showing all Senators present.

The President announced that he had read and approved the Journal of the Fifty-Fifth Day.

At this time, the following introductions were made to the members of the Senate:

Senator Kuroda introduced 36 second and third graders from Kunia Elementary School, together with their teachers Mrs. Karen Flatt and Mrs. Kathleen Umemura. Also introduced was Mrs. Helen Mandrial, a parent.

Senator Hulten then introduced 45 fourth and sixth grade students from Windward Preparatory School. Also introduced were teachers Mrs. Bell and Mrs. Conover and a parent, Mrs. Kramer.

The President introduced Carmen Maymi, Director of the Women's Bureau, Department of Labor, and her daughter Rosa. The President also introduced Mary Kramer, Chief of Economic Status and Opportunities Branch Women's Bureau.
