Thursday, January 29, 1976

The Senate of the Eighth Legislature of the State of Hawaii, Regular Session of 1976, convened at 11:30 o'clock a.m., with the President in the Chair.

The Divine Blessing was invoked by Pastor Jerry Terui of the Moanalua Gardens Missionary Church, after which the Roll was called showing all Senators present, with the exception of Senators Anderson, Saiki and R. Wong, who were excused.

The President announced that he had read and approved the Journal of the Sixth Day.

At this time, Senator Yee introduced to the members of the Senate 28 students from the fifth grade at St. Andrew's Priory, with their teacher, Miss Karen Williams.
