SEVENTEENTH DAY

Thursday, February 12, 1976

The Senate of the Eighth Legislature of the State of Hawaii, Regular Session of 1976, convened at 11:30 o'clock a.m., with the President in the Chair.

The Divine Blessing was invoked by Father John J. Sullivan of Star of the Sea Church, after which the Roll was called showing all Senators present, with the exception of Senators Kuroda, Toyofuku and Young, who were excused.

The President announced that he had read and approved the Journal of the Sixteenth Day.

At this time, the following introductions were made to the members of the Senate:

Senator Hulten introduced forty students from Kahuku and Kailua High Schools with the TESOL program, with their teachers, Mr. William Cunningham and Mr. Curtis Heaton, and a tutor, Miss Jacqueline Chang.

Senator Ching then introduced a class from the Hawaii School for the Deaf and Blind, who has an exhibit of their paintings displayed outside of the Senate Chambers. Accompanying them was their teacher, Miss Marilyn Kim.
