#### EIGHTEENTH DAY

Friday, February 13, 1976

The Senate of the Eighth Legislature of the State of Hawaii, Regular Session of 1976, convened at 11:30 o'clock a.m., with the President in the Chair.

The Divine Blessing was invoked by Father Sean O'Rourke of the St. Anthony's Church, after which the Roll was called showing all Senators present with the exception of Senators Takitani and Young who were excused.

The President announced that he had read and approved the Journal of the Seventeenth Day.

At this time, Senator Yee introduced to the members of the Senate 29 fourth grade students from St. Andrew's Priory School, and their teacher, Mrs. White.

Senator F. Wong then introduced 21 fourth grade students from Waipahu Elementary School, and their teacher, Mrs. Gladys Tokioka.

Senator Ching introduced to the members of the Senate 15 students from the special education class at Alvah Scott Elementary School, together with their teachers Miss Aimee Hokama, Miss Janice Furuhashi, Mrs. Carolyn Yamada and Mr. Michael Tom.

Senator Ching also introduced 72 fourth and fifth grade students from Waipahu Elementary School, together with their teachers, Mrs. Eva Miyazaki, Mrs. Mildred Kimura, Mrs. Betty Hashimoto, Mrs. Agnes Sugiyama and Miss June Saito.

At this time, Senator Kuroda introduced the members of the Pacific Islands Development Commission as follows:

"Mr. President and Members of the Senate:

On Wednesday, February 11, this Body adopted Senate Concurrent Resolution No. 38, commending the Pacific Islands Development Commission. This morning, we are privileged to have on the Senate floor, the principals, or their representatives, cited in the resolution.

As a member of the PIDC Tourism Council and the sponsor of the resolution, it is my pleasure to introduce, first, the newly installed President of the PIDC, the Honorable George Ariyoshi, Governor of the State of Hawaii.

A Commissioner since the 1971 inception

of the PIDC, who supported the personal efforts of the late Governor John A. Burns, the High Commissioner of the Trust Territory of the Pacific Islands, headquartered in Saipan, the Honorable Edward E. Johnston.

A Commissioner since his appointment as Governor of American Samoa in 1975, and former Congressman from North Carolina, having served three terms, the Honorable Earl B. Ruth.

The fourth Commissioner, Governor Ricky Bordallo of Guam, is not able to be here. He is represented by the Lieutenant Governor of Guam, the Honorable Rudolph Sablan.

The PIDC has spent its early efforts in two areas of interest—the tuna fishing industry and the visitor industry. Several Pacific countries have joined the PIDC Tourism Council, beginning in 1973.

We are privileged to have with us the Honorable Sir Albert Henry, Premier of the Republic of the Cook Islands.

From the Republic of Nauru, representing President Hammer deRoburt, is the Honorable Kinsa Clodumar, Project Officer of Civil Aviation.

From the Kingdom of Tonga, representing the Honorable Baron Vaea, Minister of Labor, Commerce and Tourism, is the Honorable Alasdair Buchanan, Director of Tourism.

From the Marshall Islands, representing Micronesian participation in PIDC activities, is the Honorable Amato Kabua, Senator, Marshall Islands Legislature.

Also with us is the Director of the Department of Planning and Economic Development, State of Hawaii, Mr. Hideto Kono.

Last but not least, the driving force that has brought the PIDC from its infancy to its maturity, the Executive Director of the PIDC and head of the Division of Economic Development, Mr. Andrew Gerakas."

The Commissioners of the Pacific Islands Development Commission were presented with carnation leis by Senators King, George and Saiki.

The President then spoke as follows:

"Governor Ariyoshi and other distinguished gentlemen:

We welcome you to the Senate Chambers. We know that what you are trying to do is not only for the people of the State of Hawaii, but for the people of the entire Pacific area.

Thank you very much for your presence today."

At 11:41 o'clock a.m., the Senate stood in recess subject to the call of the Chair.

## THIRD READING

Senate Bill No. 1771-76:

Senator Nishimura moved that S.B. No. 1771-76, having been read throughout, pass Third Reading, seconded by

Senator O'Connor.

At this time, Senator Nishimura rose to speak in favor of the bill as follows:

"Mr. President,

The bill before us this morning submits the question: Shall there be a Convention to propose a revision of, or amendments to, the Constitution to the electorate at the General Election of 1976?

By enacting this bill, we will be submitting that question to the electorate prior to the time mandated by the Constitution. Our Constitution provides that the Lieutenant Governor shall certify the question to be voted at the first general election following the expiration of 10 years since the last time the question was submitted to the electorate. But the Legislature may submit the question to the voters before the 10-year period.

I feel that the time is appropriate to let the electorate decide whether we should have a Constitutional Convention, so that proposed constitutional amendments relating to initiative, referendum and recall; limitation of the term of the governor; a full time Legislature; a unicameral Legislature, and others, may be taken up at one time and considered in relation to the other parts of the Constitution.

The response of the electorate will give the members of this Legislature some guidance as to how their constituency and the majority of the people of this State feel about constitutional changes. I, for one, welcome that guidance.

If the electorate answers in the affirmative, we should be considering at the next legislative session, questions relating to the number of delegates, the time

of their election and the time of the Convention.

I should like to note, Mr. President, that at the time this bill was being considered in Committee, the question was raised whether it would not be more appropriate to adopt a concurrent resolution to request the Lieutenant Governor to submit the question to the electorate. In this regard, we wish to note that a concurrent resolution is an expression of the sense of the Legislature and would not legally mandate the Lieutenant Governor to submit the question to the voters.

Although we have no reason to believe that the Lieutenant Governor would not abide by the request of the Legislature... and, in fact, I believe that he wholeheartedly supports the immediate convening of a Constitutional Convention...we want to avoid any possible legal entanglement. Therefore, your Committee on Judiciary reported out S.B. No. 1771-76.

I urge a favorable vote on this bill.

Thank you."

The motion was put by the Chair and carried, and S.B. No. 1771-76, entitled: "A BILL FOR AN ACT RELATING TO A CONSTITUTIONAL CONVENTION", having been read throughout, passed Third Reading by not less than two-thirds vote of all the members to which the Senate is entitled, on the following showing of Ayes and Noes:

Ayes, 23. Noes, none. Excused, 2 (Takitani and Young).
