

TWENTIETH DAY

Wednesday, February 18, 1976

The Senate of the Eighth Legislature of the State of Hawaii, Regular Session of 1976, convened at 11:30 o'clock a.m., with the President in the Chair.

The Divine Blessing was invoked by Reverend Satoru Hori of the Honpa Hongwanji Mission, after which the Roll was called showing all Senators present with the exception of Senator Yee who was excused.

The President announced that he had read and approved the Journal of the Nineteenth Day.

At this time, Senator Young introduced to the members of the Senate 75 sixth grade students from Waipahu Elementary School, together with their teachers, Mrs. Evelyn Nakasone, Mrs. Lenore Inoue and Mr. Tracy Schofield.

Senator Chong then introduced to the members of the Senate 29 students from the citizenship training class at McKinley Community School, and their teacher, Mrs. Joanne Steiger. The students are from Thailand, Japan, Korea, Poland and Hong Kong.
