

## TWENTY-THIRD DAY

Monday, February 23, 1976

The Senate of the Eighth Legislature of the State of Hawaii, Regular Session of 1976, convened at 11:30 o'clock a.m., with the President in the Chair.

The Divine Blessing was invoked by the Reverend Sanford Hashimoto of the Kapahulu Bible Church, after which the Roll was called showing all Senators present, with the exception of Senator Anderson, who was excused.

The President announced that he had read and approved the Journal of the Twenty-Second Day.

Senator R. Wong then spoke for the passage of the bill as follows:

"Mr. President, this bill is a housekeeping measure which affects the City and County of Honolulu and the County of Hawaii.

It seems that in the Charter revision in 1973, the Special Assessment Improvement section in the Ordinance was changed to the language which said 'as provided by law'. There is no present law on the books. With the passage of this bill, the County can proceed, according to our bond counsel and the City bond counsel, in clearing a legal cloud which has been created by this slight error in the Charter revision.

Therefore, Mr. President, I ask the members to support this measure."

The motion was put by the Chair and carried, and Stand. Com. Rep. No. 31-76 was adopted and S.B. No. 1191, entitled: "A BILL FOR AN ACT RELATING TO IMPROVEMENTS BY ASSESSMENT AND THE FINANCING THEREOF", having been read throughout, passed Third Reading on the following showing of Ayes and Noes:
