

## TWENTY-FOURTH DAY

Tuesday, February 24, 1976

The Senate of the Eighth Legislature of the State of Hawaii, Regular Session of 1976, convened at 11:30 o'clock a.m., with the President in the Chair.

The Divine Blessing was invoked by Mr. Harold Jones of Campus Crusade for Christ, after which the Roll was called showing all Senators present with the exception of Senator Anderson who was excused.

The President announced that he had read and approved the Journal of the Twenty-Third Day.

At this time, Senator Takitani introduced to the members of the Senate students from various high schools throughout the State who are participating in the annual Student Observer Program.
