

## TWENTY-FIFTH DAY

Wednesday, February 25, 1976

The Senate of the Eighth Legislature of the State of Hawaii, Regular Session of 1976, convened at 11:30 o'clock a.m., with the President in the Chair.

The Divine Blessing was invoked by the Reverend Richard Schumm of Our Redeemer Lutheran Church, after which the Roll was called showing all Senators present with the exception of Senators Anderson, Hulten, Kuroda, R. Wong and Yim, who were excused.

The President announced that he had read and approved the Journal of the Twenty-Fourth Day.

## MESSAGES FROM THE GOVERNOR
