TWENTY-NINTH DAY

Tuesday, March 2, 1976

The Senate of the Eighth Legislature of the State of Hawaii, Regular Session of 1976, convened at 11:30 o'clock a.m., with the President in the Chair.

The Divine Blessing was invoked by Dr. Clifford Hoff of the University Avenue Baptist Church, after which the Roll was called showing all Senators present, with the exception of Senators Kawasaki and Yim, who were excused.

The President announced that he had read and approved the Journal of the Twenty-Eighth Day.

THIRD READING

Senate Bill No. 243, S.D. 1:

Senator Kuroda moved that S.B. No. 243, S.D. 1, pass Third Reading, seconded by Senator Yamasaki.

Senator Kuroda then spoke for the passage of the bill as follows:

"Mr. President, the purpose of this bill is to amend our income tax law, removing what I believe is a discriminatory clause in our laws.

I am certain that in the Special Session of 1957, some eighteen years ago, there was a need to include a clause in our tax laws which afforded Hawaii residents sixty-five years and older, a tax exemption on all income which was derived from out of State. This was referred to as the 'Kaiser amendment'. (This law allows any person sixty-five years or older to take up residence in our State and enjoy all of the benefits without paying a dime of tax on their retirement income from wherever, as long as it is from out of State.)

Yet, our own Kamaaina residents, when they reach the golden age of retirement must continue to pay income taxes on their locally earned retirement pensions.

This bill changes the law, removing this language. After the first of July of this year, persons becoming residents of Hawaii will be required to pay income taxes on their income, regardless of source.

I urge my fellow Senators to vote Yes on this bill.

Thank you."

The motion was put by the Chair and carried, and S.B. No. 243, S.D. 1, entitled: "A BILL FOR AN ACT RELATING TO THE PAYMENT OF INCOME TAXES", having been read throughout, passed Third Reading on the following showing of Ayes and Noes.

Ayes, 23. Noes, none. Excused, 2 (Kawasaki and Yim).
