#### THIRTY-SEVENTH DAY

#### Friday, March 12, 1976

The Senate of the Eighth Legislature of the State of Hawaii, Regular Session of 1976, convened at 11: 30 o'clock a.m., with the President in the Chair.

The Divine Blessing was invoked by the Reverend Ford G. Coffman of the Windward United Church of Christ, after which the Roll was called showing all Senators present with the exception of Senator F. Wong, who was excused.

The President announced that he had read and approved the Journal of the Thirty-Sixth Day.

At this time, the following introductions were made to the members of the Senate:

He then introduced their hosts, the Kaneohe Civitan Club, Mr. and Mrs. Robert Biondine, Mr. and Mrs. Fred Schilling and Mr. Walter Kaaihili and Mrs. Ricky Naipo, a nurse who accompanied the group from Hilo.
