Thursday, March 25, 1976

The Senate of the Eighth Legislature of the State of Hawaii, Regular Session of 1976, convened at 11:00 o'clock a.m., with the President in the Chair.

The Divine Blessing was invoked by Reverend Masao Ichishima of the Tendai Mission, after which the Roll was called showing all Senators present with the exception of Senator R. Wong who was excused.

The President announced that he had read and approved the Journal of the Forty-Fifth Day.
