

FORTY-SEVENTH DAY

Monday, March 29, 1976

The Senate of the Eighth Legislature of the State of Hawaii, Regular Session of 1976, convened at 11:00 o'clock a.m., with the President in the Chair.

The Divine Blessing was invoked by Mr. Samuel M. Saffery of the Liliuokalani Protestant Church, after which the Roll was called showing all Senators present.

The President announced that he had read and approved the Journal of the Forty-Sixth Day.

DEPARTMENTAL COMMUNICATIONS

The following communications (Dept. Com. Nos. 16 and 17) were read by the Clerk and were disposed of as follows:

A communication (Dept. Com. No. 16), transmitting copies of The Economy of Hawaii, 1976 - Annual Economic Report and Outlook, prepared by the Department of Planning and Economic Development, was referred to the Committee on Ways and Means.

A communication (Dept. Com. No. 17), transmitting copies of a report on Problems with Student/Health Aide Ratio and Problems Regarding Job Status of Health Aides, prepared by the Department of Health in response to Special Committee Report No. 2 on School Health Services Project, was referred to the Committee on Education, then to the Committee on Health.

Wong rose to explain that the House amendment "clearly indicates that the City and County of Honolulu, which is the responsible agency for shoreline management within the City and County of Honolulu, will have jurisdiction over shoreline structures", thereby eliminating the present confusion due to dual jurisdiction.

The President appointed Senator Yee to escort Mr. John W. Warner to the rostrum. The President then presented Mr. Warner with a certified copy of the resolution just adopted, and welcomed him to Hawaii.

Mr. John W. Warner then addressed the members of the Senate as follows:

"It is indeed a pleasure to come to Hawaii. Because I was a sailor at the age of 17 and once the Secretary of the Navy, Hawaii will always be a second home for me.

I am here on a trip embracing a swing through the Pacific. People are surprised sometimes to learn there is just as much enthusiasm for the Bicentennial west of the Pacific, and indeed in the Pacific, as in any of the original thirteen colonies.

Today, I will be working with the Chairman of the Bicentennial Commission and Executive Director. This evening, I will be meeting with the members of the Commission.

I can tell you unequivocally, the program the Bicentennial Commission has adopted for the State of Hawaii, with the support given by the Senate, the House and the Governor, will

equal anything to be found elsewhere in the United States.

I congratulate the citizens of Hawaii.

And if I may fall back on an old political adage that we in the East use: 'As goes the presidential election, so goes the Nation'...as goes the Bicentennial in the great State of Hawaii, so goes the success of the Bicentennial nationwide.

Thank you."

RE-REFERRAL OF A HOUSE BILL

The President made the following re-referral of a House Bill that was received on Wednesday, March 17, 1976:

At this time, Senator Toyofuku rose on a point of personal privilege to speak as follows:

"Mr. President,

On Friday, in the ILWU newspaper, the voice of the ILWU, there appeared two articles entitled: 'Hard-Won Workers' Rights are in Jeopardy' and 'Senate Betrays Hawaii's Workers'. Both were written by Shoji Okazaki, a lobbyist for ILWU.

The manner of reporting, Mr. President, is highly irresponsible and smacks of yellow journalism. I consider both articles to be a personal affront to me, and an insult to the integrity and intelligence of all twenty-five members of the Senate. Furthermore, Mr. President, it insults the intelligence of the reader and the members of the ILWU.

The writer will lead everyone to believe that S.B. No. 2326-76, S.D. 1, the unemployment bill, will 'punish' all employees and destroy the employment security of every employed and unemployed worker in our community.

This writer would lead everyone to believe that the Governor of the State, the Director of the Department of Labor, the Senate, and all of the employers who suggested this bill, are totally irresponsible in attacking the workers in our community. Some people may wonder who's right and who's wrong.

The Governor, the Director, and

the Senate have demonstrated their integrity and their ability to carry out their responsibilities. What about the writer? Has he demonstrated or displayed responsibility to this community of ours?

Mr. President, let us examine the nature of these charges.

The writer uses terms such as 'to punish', 'to discriminate', 'to betray', 'to banish'...mind you, Mr. President, 'to banish', 'to betray'...to use such words as 'overkill', 'dismayed by the Administration bill', 'contrary to the basic purpose of the law'.

These words, Mr. President, are used to incite, to foment, to instigate. This is insincere language to connote that we are monsters from another world, here to clobber the workers of the State.

I believe that the writer is misguided and does not understand the true intent of the bill. He, therefore, in turn has misguided his membership, who are truly his employers. Because he is misguided, he chooses this means to portray us as monsters and himself as a poor, innocent and insulted person.

I submit here that S.B. No. 2326-76, S.D. 1, is not an anti-labor bill. This is an anti-abuse, anti-fraud bill. The Unemployment Insurance Compensation program is a labor-oriented program. It is designed to provide temporary relief to a worker in need of subsistence and assistance from his government and his community. This is not a welfare or a handout program.

Those who choose to abuse the generosity of our government and our community must be put down and disqualified. This bill does not seriously weaken employment security, but, rather, strengthens it. The person who is unemployed but actively seeking employment, would be insured of assistance in the future from the program.

S.B. No. 2326-76, S.D. 1, does not punish and discriminate against persons who are unable to find further employment. Mr. President, the Senate has passed a bill to provide \$20 million to assist those who are unemployed through no fault of their own.

We have transmitted our thoughts to Congress on the Food Stamp and Welfare programs, designed to assist those on welfare through no fault

of their own. There are other programs designed to assist those who are unemployed, and this Senate has demonstrated its support for such programs.

Section I of the bill, the re-definition of a work week, is a desirable provision, and I might add, Mr. President, a reasonable one. The section would not 'punish' nor 'penalize' those who truly and earnestly are seeking employment, nor does it 'punish' those who are unemployed through no fault of their own.

This section would merely establish a standard in determining what is full time and what is part-time.

These are standards used in Prepaid Health and Temporary Disability Insurance and, I believe, this appears in union contracts also. This section does not hurt the most needy as they would lead us to believe. I repeat, Mr. President, this is not a welfare bill. We have welfare programs for the needy, and we have the State unemployment programs to assist the needy.

If the intent of the writer is to perpetuate abuses, to support the continuity of efforts at ripping off the government, then I can understand his position. However, there are responsible people in his organization--responsible to our community and our people. Therefore, I'm certain that he does not reflect the sentiments of the members of his organization.

Mr. President, I consider these articles cheap shots at my colleagues and me, and I want to impress upon our community that I will not tolerate such actions.

Last year, the same writer did the same thing. Only it was after the Session closed. He condemned certain members of the Senate, because we would not pass the bill to force employers to provide TDI coverage automatically to their union members. This year, the same bill, including one on Prepaid Health, was passed by the House and is presently in your Committee on Human Resources.

Both existing TDI and Prepaid Health laws have exempt coverage for persons covered under the Collective Bargaining Agreement, and this is rightfully so. When these programs were enacted, they chose to be exempted. However, now they try to enter through the back door.

Both bills have been killed in my Committee because these are negotiable items, and can be attained through negotiations over the table. Mr. President, your Committee on Human Resources has taken a stance that government should not interfere nor meddle in the collective bargaining process. Therefore, all bills pertaining to negotiable items are automatically set aside.

I think you can understand the reasons for my anger, Mr. President. I think you can also understand the qualities and character of the writer.

I might add that all of the employee-oriented benefit programs came out of your Committee on Human Resources, such as improvements and expansion of our Worker's Compensation program, our Prepaid Health and TDI programs. These all originated in the Senate Human Resources Committee.

Today we have one of the most progressive employee benefit programs in the entire country.

The thing that irks me, Mr. President, is that the Senate was never singled out nor credited for our efforts. Instead, the writer says ugly things about the Senate because he has misunderstood and overreacted to a bill.

One time, I can forgive and forget--the second time, I cannot.

Mr. President and fellow colleagues, thank you for your indulgence. Thank you for bearing with me while I vent my rage."
