Senator Toyofuku explained that the House had made three amendments to this bill. They deleted the words "and/or experience" in the qualifications for the Director. Another proposal is to consider the judicial side of the question which has to do with the Juvenile Justice Master Plan. The third amendment deleted the section of the bill which provided for the transfer of the Youth Affairs Office to the new Office of Children and Youth, as this transfer will be taken care of under a separate bill.
