Monday, April 5, 1976

At this time, Senator Taira rose to speak as follows:

"Mr. President, on this day a year ago, we lost a great leader...I would say the greatest leader of our times. It was a sad day of mourning throughout Hawaii.

For many of us in this Body, as well as for many of our colleagues across the Hall, the passing of Governor Burns also represented a deep personal loss. We respected him. We admired him. We loved him. That so many held him in such deep affection was the mark of his influence among us.

Certainly, his achievement in bringing Statehood to Hawaii as our last Delegate to Congress was an accomplishment that in itself ranks among the most prominent in the history of Hawaii. Yet, there was more, much more in his lifetime of service in behalf of the people of our Islands.

During his three terms as Governor, far-reaching changes were made in our social, economic, political, educational, and other institutions of our society. Few will deny that the imprint of his Administration will be indelibly impressed upon every aspect of our lives for many years to come.

Yet, it was characteristic of Governor Burns and his quiet style of leadership that he never took personal credit for the progress he influenced.

Perhaps, Mr. President, one of his greatest achievements was the harmony and spirit of cooperation that he generated between the Executive and the Legislative branches of government. While he fully respected the doctrine of separation of powers, Governor Burns opened up dialogue between our respective branches of government.

Through his leadership, the constitutional gulf between the Executive and the Legislature was quietly bridged so that, together, we were able to develop those many new programs instituted during his Administration.

Mr. President, I remember, too, that in his final address before the Legislature--weakened though he was by the illness to which he finally succumbed--Governor Burns called upon all of us to continue...to continue dreaming that impossible dream that he left as a legacy to all Hawaii.

Throughout his life, Governor Burns conducted himself--as he treated all with whom he came in contact-with dignity. He holds a special place in our hearts, and his memory remains an inspiration and a shining example for all of us.

Mr. President, I believe it very, very appropriate that a standing vote be taken on the resolution before us. Before calling for the vote, I will yield to the Minority Leader."

Senator Yee then rose to speak:

"Mr. President, I, too, rise in great reverence for the man we are honoring this morning.

I served with him during his three terms as Governor, and found him to be a friendly, warm and kind person. He had the island people at heart-he never shunned anyone. A great concern many of us had when he was first elected Governor, was whether he would be too liberal or too pro-labor--but he brought concensus between labor and business, and the community benefited.

I would like, at this time, with the participation of the Minority, to pay tribute to the late Governor John A. Burns."

The motion was put by the Chair and carried by a rising vote, and S.R. No. 102 was adopted.

A moment of silence in memory of the late Governor John A. Burns was then observed by the members of the Senate.
