Thursday, April 8, 1976

The Senate of the Eighth Legislature of the State of Hawaii, Regular Session of 1976, convened at 11: 30 o'clock a.m., with the President in the Chair.

The Divine Blessing was invoked by the Reverend John Williams of Aina Haina Church of God, after which the Roll was called showing all Senators present.

The President announced that he had read and approved the Journal of the Fifty-Fourth Day.

At this time, Senator Chong introduced to the members of the Senate Dr. Bertram Brown, Director, National Institute of Mental Health, from Washington, D.C., and Mr. K. Patrick Okura, his Executive Assistant, who are visiting the various departments in Hawaii.

STANDING COMMITTEE REPORT
