FIFTY-SIXTH DAY

Friday, April 9, 1976

The Senate of the Eighth Legislature of the State of Hawaii, Regular Session of 1976, convened at 11:30 o'clock a.m., with the President in the Chair.

The Divine Blessing was invoked by Mr. Sam Sherrard of Hawaii Youth for Christ, after which the Roll was called showing all Senators present with the exception of Senator Saiki who was excused.

The President announced that he had read and approved the Journal of the Fifty-Fifth Day.

At this time, the following introductions were made to the members of the Senate:

Senator Yee introduced 18 fourth grade students from Hawaiian Mission Elementary School, together with their teacher, Miss Molly AuYuen, and parents, Mrs. Yamanaka and Mrs. Carvalho.

Senator Yee then introduced 18 fifth grade students from Bingham Tract School and their teacher, Mrs. Mary Lou Gollob, a former legislative assistant to Senator Richard Henderson.

Senator Yee also introduced 100 fifth grade students from Ala Wai Elementary School, together with their teachers, Mrs. Thelma Odo, Mrs. Betty Muraoka, Mrs. Jean Dollar and Mrs. Alice Arakaki, and student teacher, Mr. Marvin Macadangdang.
