Monday, April 12, 1976

The Senate of the Eighth Legislature of the State of Hawaii, Regular Session of 1976, convened at 11:30 o'clock a.m., with the President in the Chair.

The Divine Blessing was invoked by the Reverend Robert Allen of Christian Research Hawaii, after which the Roll was called showing all Senators present.

"Mr. President, we have until midnight today to decide that.

I released the Senators on the Ways and Means Committee over the weekend, telling them that there will not be a conference. I wish to state for the record that there was an informal meeting with the House and we presented to them the Senate position based on various measures. To this day, we have not received a response from the House."

Senator Anderson then rose on a point of personal privilege and stated as follows:

"Mr. President, it seems that the conference committee chairmen, or the Managers, for some reason have obtained this prerogative again where the committee members sit and wait for hours while the two chairmen are in locked offices and doors trying to get their own points of view in, ignoring the conference committee members...and I'm not speaking of just the Ways and Means Committee. I'm just wondering if the opposition party and the media are going to have a chance to sit in and listen to the debate, pro and con."

Senator R. Wong then responded as follows:

"Mr. President, there is no deal behind closed doors. The position paper that was offered the Speaker and the Chairman of the House Finance Committee was a position arrived at by the Ways and Means Committee and it not only includes the tourist tax, but also the Florida Law, the 60% assessments and other related matters which the Senate deems important as part of the Majority Program.

Also, Mr. President, I would like to point out that there will not be a conference committee meeting where the press and the media are not invited. They are welcome to come. I make that statement for the record that when the conferees do meet, the meeting will be open to the people and the press.

Thank you, Mr. President."

At 11:55 o'clock a.m., the Senate stood in recess until 7:00 o'clock p.m. tonight.
