

FIFTY-EIGHTH DAY

Tuesday, April 13, 1976

The Senate of the Eighth Legislature of the State of Hawaii, Regular Session of 1976, convened at 11:30 o'clock a.m., with the President in the Chair.

The Divine Blessing was invoked by Mr. Lud Amerding of the Oahu Evangelical Association, after which the Roll was call showing all Senators present.

The President announced that he had read and approved the Journal of the Fifty-Seventh Day.

"Mr. President, I hold the humpback whale in high affection and esteem. Over the years, I have watched them with much pleasure when they are spouting offshore on their periodic visits here. And I am certainly in total support of the international movement to save the humpback whale.

However, I rise to speak against this resolution.

In the first place, the humpback whale is not indigenous to Hawaii. We have equally appealing indigenous animals, such as the monk seal, for example, that could be adopted for a State symbol.

It's actually a relative newcomer to Hawaii, having only arrived about a hundred years ago... the whalers in Lahaina did not hunt the humpback whale. Not only is this whale a newcomer, but, in a sense, a tourist rather than a resident, as it only comes to the islands periodically to appear offshore... and it certainly is a wonder to behold.

The people who are involved in the international movement to save the whale, testified that they supported the resolution because they wanted a symbol for their cause. I am not sure the State should adopt this mammal for a cause.

For these reasons, Mr. President, I would urge that we vote against this resolution."

Senator F. Wong then rose in support of the resolution, stating that "while the humpback whale is not indigenous to the State of Hawaii, it has been coming here far longer than any of us has lived on this earth. I consider it a kamaaina".
