Wednesday, April 14, 1976

The Senate of the Eighth Legislature of the State of Hawaii, Regular Session of 1976, convened at 11:00 o'clock a.m., with the President in the Chair.

The Divine Blessing was invoked by the Reverend Mel Walter of the First Baptist Church, Windward, after which the Roll was called showing all Senators present with the exception of Senator R. Wong, who was excused.

The President announced that he had read and approved the Journal of the Fifty-Eighth Day.

At this time, Senator Chong introduced twenty-one students from the fourth grade at Hanahauoli School, with their teacher, Mr. Kahele Kukea and parents, Mrs. Mae Kawasaki and Mrs. Carol Sunahara.

SENATE CONCURRENT RESOLUTIONS

The following concurrent resolutions (S.C.R. Nos. 120 and 121) were read by the Clerk and were disposed of as follows:

A concurrent resolution (S.C.R. No. 120), entitled: "SENATE CONCURRENT RESOLUTION RECOGNIZING AND COMMENDING THE U.S. ARMY MILITARY ASSISTANCE TO SAFETY AND TRAFFIC (MAST) PROGRAM PROVIDING EMERGENCY HELICOPTER SERVICE TO THE CIVILIAN COMMUNITY", was jointly offered by Senators Kuroda, Chong, Takitani, Anderson, Yim, Saiki, Taira, Young, King, Hulten, Ushijima, Yamasaki, F. Wong, Nishimura, Soares, George, Yee, Henderson, Ching, R. Wong, Leopold, Kawasaki, O'Connor, Hara and Toyofuku.

On motion by Senator Kuroda, seconded by Senator Chong and carried, S.C.R. No. 120 was adopted.

Senator Kuroda then introduced to the members of the Senate Major James A. Williamson, Commander of the 68th Medical Detachment and Captain Gerald Nagle, Operations Officer of the 68th Medical Detachment.

Senator Kuroda then escorted Major Williamson to the rostrum where the President presented him with a certified copy of S.C.R. No. 120 which was just adopted. Major Williamson then addressed the members of the Senate expressing their appreciation for the adoption of the resolution

and added that they enjoy participating in the MAST program and hope to continue their efforts in this program for a long time into the future.

Senator Kuroda then introduced to the members of the Senate Mr. Lee Winagle, a citizen-observer who called attention to the service of the 68th Medical Detachment in the program.

Senator Yee then introduced to the members of the Senate sixty blind students, from ten to eighteen years of age from California, and a group of thirty-three counselors who accompanied them. He then introduced Mr. Norman Kaplan, the founder and Executive Director of the group, and Mrs. Barbara Kozuma, the Hawaii Coordinator for Project Aloha.

Senator Yee then escorted Mr. Kaplan to the rostrum where the President presented him with a certified copy of S.C.R. No. 121 which was just adopted. Mr. Kaplan then addressed the members of the Senate expressing deep appreciation not only for the adoption of the resolution but also for the warm aloha extended to the group by the people of Hawaii.

Senator F. Wong then spoke against the measure as follows:

"Mr. President, in speaking against the bill, I do so with a great deal of trepidation because it is in a sense voting against motherhood and apple pie. The reason for this position, Mr. President, is because the bill as I read it and as interpreted to me by the Attorney General, is clearly discriminatory. However, the heart of the bill is contained on page 4.

The present law states that any lease enjoys the benefits of being modified or having restrictions eliminated in order to secure financing. The bill as contained in conference draft one, limits those rights to only intensive agriculture and special livestock leases. This excludes, Mr. President, nine other categories of leases that now enjoy that exemption or that modification. Those include pasture leases, commercial timber use leases, quarry leases, mining leases, recreational use leases, watershed leases, residential leases, commercial and industrial leases, hotel, apartment and motel leases, resort leases and unclassified leases. To deny this exemption, Mr. President, is clearly discriminatory. Unfortunately, this matter could not have been resolved in conference in an equitable way.

In rising to speak against it and

voting against it today, Mr. President, I do so to indicate to the members of this Body that corrective legislation is needed to bring about an equitable solution in 1977 and I trust that this matter will be given high priority by the next Legislature."

Senator Kawasaki then spoke against the bill as follows:

"Mr. President, I'm a little concerned about the language of the bill which empowers the Board of Land and Natural Resources to cancel what is today an existing lease.

Let's just assume that a person has a 20-year lease with one or two years remaining. He applies to the Land Board and is able to effectuate a cancellation of his present lease, thereby enjoying another 35 years of additional lease under the State Leasing Agreements, for a total number of 55 years.

It just seems to me that when a person has the privilege of having 20 years of lease privileges then he should vie for the extension of the lease for another 35 years with any other person who may be interested in a similar lease in a similar land owned by the State. It gives me the impression that this is privileged legislation.

If we have certain problems with people who want to obtain mortgages, I think the language could be so perfected that we give some consideration to these people, providing they are going to continue an enterprise of great value to the State and in the judgment of the Board of Land and Natural Resources, it is justified--but a blanket language that almost assures that a present lessee can get another 35 years over anyone else who may be interested in such a piece of land, I think is very privileged legislation. For that reason, I have to vote against it."

Senator Chong then spoke for the measure as follows:

"Mr. President, I rise to speak for this bill. By way of background, this honorable Body passed Senate Resolution No. 44 at the last session, authorizing your Senate Health Committee to monitor the new national health planning and resources development act, also known as PL 93-641, which in effect created throughout the United States, a new health planning structure. We are one of the first states in the United States to pass enabling legislation.

Your Senate Health Committee held several interim hearings and informational meetings on this issue and we came back early in January of this session to include and expand the concept of the new national legislation to include and to make into legislation, the citizen's participation.

This bill establishes the concept of sub-area grass roots health planning councils throughout the State of Hawaii. The national legislation was silent with regard to the details on this, so we decided to make it part of the State law. It is our intent that this will be a permanent vehicle for citizens' input, a permanent vehicle into the health planning process.

The establishment of these sub-area health planning councils is consistent with the intent of the health resources and development act of last year to assure the greatest amount of public participation in health planning. As established, sub-area health planning councils gather the viewpoints of citizens and recommend and review plans with respect to health planning in each area. The bill also makes sure that the recommendations of the sub-area councils are considered by the overall agencies responsible for planning health care and services.

I'd like to add, Mr. President, that the Congress of the United States authorized approximately one billion dollars to carry out this new Federal Act which consolidates all comprehensive health planning, regional medical programs and Hill-Burton authorities. Hawaii should be eligible to therefore qualify for considerable amounts of money.

The control of the new State Health Planning Agency and the sub-area councils will be people who will be appointed by the Governor, and your Committee made sure that it would be with the advise and consent of the Senate."

Too long in Hawaii we have had offenses committed with firearms for which the penalty has not been as severe as it should be.

Too long have we gone in a situation where firearms are used by the criminal element in our community in a rampant situation without really having any restrictions in their use.

Too long have we had organized crime killings in this State discovered and yet no proper sanction for the killer once it has been determined that he used firearms in his crime.

Mr. President, the people of our State have reached a point based upon the findings of your various committees in this area that they demand legislation of this nature. This legislation would establish mandatory minimum sentences for crimes committed with firearms. This is a new approach in this State--a new approach to our prior sentencing law and a new approach of handling citizens of this nature.

I believe that this is a bill which the citizens of Hawaii want and it is a bill which will insure that in the future, when crimes are committed with firearms, those people who perpetrate such crimes will be punished severely and be placed in a situation where others in the community should know not to use firearms in any circumstance and nonetheless in the commission of crimes.

I urge all to vote for this measure."

Senator Kawasaki, in speaking for the bill, stated as follows:

"Mr. President, I would like to urge a unanimous vote on this bill but I want to, in one of these rare instances, give due credit to the Chairman of the House Judiciary Committee and to the members of the House. This is one of Representative Stanley Roehrig's pet bills and ideas.

Another is on the agenda today in Conference Committee Report No. 39-76 on House Bill No. 2932-76, H.D. 2, S.D. 1, C.D. 1.

Consonant with the previous speaker's views, I think this is a step in the right direction in providing for this community some effective, fair law, and I would hope that we can get a unanimous vote on both of these bills."

Senator Leopold then spoke against the measure as follows:

"Mr. President, when this bill went into conference, I stated on the floor that it had constitutional problems and the Attorney General confirmed my fears about an unconstitutional provision within the measure. Unfortunately, rather than keeping the measure clean of constitutional problems in the conference draft, they have replaced one unconstitutional provision with another, and I speak specifically to the section regarding non-residents.

This bill purports to charge non-resident differentials for moorage fees and for application fees. The language is unclear as to the amount of the fee the non-resident will be paying for an application. It just states no less than \$100. I know the House preferred that the fee be \$1,000 for a non-resident, and while it's perhaps in vogue to attack these non-residents, I think it's very discriminatory and will give us a national 'black-eye' in the boating community around the world.

Relating to some of the provisions that are still in the bill from the Senate Draft that I spoke of earlier, I'm very much concerned about the provision in the bill which allows

this small boating program to be continued to be administered by a division which has shown itself incapable of administering the program properly, and this of course, was cited by the Legislative Auditor in its recent legislative audit to the Legislature.

I am very dissatisfied with this measure. I still think it contains constitutional problems. It's reduced what I thought was an equitable percentage for live-aboards at the Ala Wai and Keehi Lagoon Harbors and I'm very disturbed that they reduced this to 15% rather than 25%. Basically I'm very unhappy about the bill. I think it treats the people who live on these harbors in a discriminatory manner and I urge the members to vote against it."

Senator O'Connor then spoke in favor of the bill as follows:

"Mr. President, if the charge to a non-resident is higher than the charge to a resident in any circumstance, then we best go back and review all of our practices in this State in many, many respects, and not the least of which is our statutory requirement for non-resident tuition at our University.

Every state, Mr. President, does this and if it is unconstitutional, I have yet to see a case anywhere which prohibits a State from making such a charge. When the taxpayers of the State provide a benefit to the citizens of the State, then it is only wise for that State to charge non-citizens who are non-taxpayers a larger sum to use that facility.

This bill, Mr. President, is a bill which will provide direction to the Department of Transportation where no direction has existed to this time. This is a bill which will provide one organization which is charged with the management and growth and development of our small boat harbors where no such organization has existed to this time. I will admit that that organization still remains in the Department of Transportation, but that department is uniquely suited to handle this problem, where other divisions of this government are not.

The bill, Mr. President, is in toto a bill long needed in this jurisdiction and I would ask all members of this Body to vote for it."

Senator Leopold then remarked as follows:

"Mr. President, I don't believe that the former speaker's analogy to the University differential is accurate and pertinent to this case because in the case of a University differential, the non-resident is receiving a service, but merely to pay at least \$100 for an application fee when there is no service provided, I think is much different than providing a service by way of an education to your non-resident in the University system.

One final quote that I'd like to leave in the minds of the members of this Body regarding the housing of this program within the Harbors Division, is a quote from the legislative audit, 'the continued housing of the recreational boating program within the Department of Transportation is bound to work to the detriment of recreational boating'."
