Monday, April 19, 1976

The Senate of the Eighth Legislature of the State of Hawaii, Regular Session of 1976, convened at 2:00 o'clock p.m., with the President in the Chair.

The Divine Blessing was invoked by Mr. Douglas Johnson of the Campus Crusade for Christ, after which the Roll was called showing all Senators present with the exception of Senators Anderson, Yee and Young, who were excused.
