

NINTH DAY

Monday, January 31, 1977

The Senate of the Ninth Legislature of the State of Hawaii, Regular Session of 1977, convened at 11:30 o'clock a.m., with the President in the Chair.

The Divine Blessing was invoked by the Reverend Chris Carver of the First Church of the Nazarene, after which the Roll was called showing all Senators present, with the exception of Senators Hara and Yee, who were excused.

The President announced that he had read and approved the Journal of the Eighth Day.

MESSAGES FROM THE GOVERNOR
