Thursday, February 3, 1977

The Senate of the Ninth Legislature of the State of Hawaii, Regular Session of 1977, convened at 11:30 o'clock a.m., with the President in the Chair.

The Divine Blessing was invoked by Reverend Keith Sears of the Kaimuki Church of the Nazarene, after which the Roll was called showing all Senators present, with the exception of Senators Saiki, Soares and Yee who were excused.

The President announced that he had read and approved the Journal of the Eleventh Day.

THIRD READING

Standing Committee Report No. 8 (H.B. No. 3, H.D. 1):

Senator R. Wong moved that Stand. Com. Rep. No. 8 be adopted and H.B. No. 3, H.D. 1, having been read throughout, pass Third Reading, seconded by Senator Yamasaki.

At this time, Senator Leopold rose to speak against the measure:

"Mr. President, I cannot support this measure, knowing as I do the arbitrary, inequitable and, in certain instances, unconstitutional way that staffing allotments are decided upon by the Majority.

I have felt very strongly about this matter for some time. As a member of the House, I filed suit in Federal court, challenging what, I thought, was an unconstitutional way that funds were allotted to the members of the House at that time. The court did have the effect of granting Minority members \$75.00 a day for their staff during sessions, as opposed to the \$32.00 a day they had been receiving.

I won't belabor the point, but just point to two examples to indicate my case. The first is that, as a Senate Republican, I receive less money for my staff during the legislative session than my House Republican colleagues—and I represent three—and—a—half to four times as many people.

The second point is that while in

the Senate everyone on the Majority side of the fence, except yourself, Mr. President, is a committee chairman and thereby could justify additional staff...in the House, there are sixteen Democrats who are not chairmen and still receive more money for their staffs than the Republicans.

I believe this is unconstitutional and would like the Clerk to record my vote as No on this bill."

Senator R. Wong then rose to speak in favor of the measure:

"Mr. President, under this bill, very briefly, the Senate is appropriated \$1.5 million and the House of Representatives \$1.9 million. These amounts represent a five percent increase over last year's appropriations. In light of inflation and the rising costs of equipment and supplies, personnel and other expenses supplied to all members of the Senate, I believe this increase is a modest and reasonable one.

Also, Mr. President, this bill appropriates \$912,000 for the Legislative Auditor, \$150,000 for special studies, \$87,000 for the State Ethics Commission, \$620,000 for the Legislative Reference Bureau, \$429,000 for the Revisor of Statutes and \$277,000 for the Ombudsman. These appropriations are necessary to enable these agencies to continue their work in their usual exemplary manner during the coming fiscal year.

I should like to call the attention of the members of this honorable Body to the fact that the appropriation to the Revisor of Statutes includes a \$220,000 appropriation to augment prior appropriations to pay for the personnel, printing and other costs involved in re-publishing the Hawaii Revised Statutes. Inclusion of this amount in the bill now before us-rather than via a separate measure-will help expedite the re-publication process, make the new volumes available sooner and, hopefully, effectuate some kind of cost savings.

Mr. President, the Ways and Means Committee has reviewed the provisions of this bill thoroughly. We have heard the budget testimonies of the legislative support agencies. We have held two public hearings on this bill for input. For the information of the members of this honorable Body, we have received no testimony against this bill.

Therefore, Mr. President, I urge all the members of this honorable Body to vote in favor of this bill."

The motion was put by the Chair

and carried, and Stand. Com. Rep. No. 8 was adopted and H.B. No. 3, H.D. 1, entitled: "A BILL FOR AN ACT MAKING APPROPRIATIONS TO PROVIDE FOR THE EXPENSES OF THE LEGISLATURE, THE LEGISLATIVE AUDITOR, THE LEGISLATIVE REFERENCE BUREAU, AND THE OMBUDSMAN", having been read throughout, passed Third Reading on the following showing of Ayes and Noes:

At 11:50 o'clock a.m., on motion by Senator Taira, seconded by Senator Anderson and carried, the Senate adjourned until 11:30 o'clock a.m., Friday, February 4, 1977.
