THIRTEENTH DAY

Friday, February 4, 1977

The Senate of the Ninth Legislature of the State of Hawaii, Regular Session of 1977, convened at 11:30 o'clock a.m., with the President in the Chair.

The Divine Blessing was invoked by Mr. Sanford Hashimoto of Kapahulu Bible Church, after which the Roll was called showing all Senators present, with the exception of Senators Saiki, R. Wong and Yee, who were excused.

The President announced that he had read and approved the Journal of the Twelfth Day.

At this time, the following introductions were made to the members of the Senate:

Senator King introduced a group of twenty Seniors from St. Louis High School, with their teacher, Mr. Rod Santos.

Senator Kuroda then introduced the Honorable Frank Barnett, the Governor of American Samoa and Brigadier General Edwin Black (Ret.), Director of Industrial Development, American Samoa, with offices here in Honolulu. These two men have just returned from the Pacific Islands Development Commission (PIDC) meeting which was held in Guam.

Senators George and Young presented leis to Governor Barnett and General Black, respectively. The President then requested the Senators to escort Governor Barnett to the dais where he addressed the members of the Senate as follows:

"Mr. President and members of the Senate.

Thank you very L. ch and I'd like to very simply say that it is a very great pleasure to be here. When I was serving as Lt. Governor, I had the good fortune to sit beside your Lt. Governor at some of our national conferences. More recently, I had the good fortune to sit beside your Governor at our Western Governor's meeting. I have had the additional good fortune to be treated well by Senator Yim, Senator Kuroda and Andrew Gerakis since being here in Honolulu. I look forward to working with all of you--seeing more of all of you in the future.

I think the only message I would

bring is that during my trip, I also visited Korea, Japan, Taiwan and Manila. While there I spoke to fishing fleet owners and operators in all of those countries with the idea of trying to develop a more viable fishing industry in our area. I think the most significant thought that I have come up with from this whole trip is that in dealing with all of these countries (and we had eleven nations and territories represented at our PIDC meeting, for instance), that there is a sense of nationalism or a sense of individual pride that overwhelms good judgment in many cases. I noted that many people are just interested in 'Is it good for me alone', and 'If it is not good for my country or my company, I don't want any part of it.

The thing that is most pleasing is the attitude that the State of Hawaii and this Body has shown in this regard. I take the very simple position that if it is good for Hawaii, up to a certain point, it is good for Samoa. And, up to a certain point, if it is good for Samoa, I think it will also be good for Hawaii. I think you believe the same way. It is good to be back home with people who think the same way I do.

Thank you very much. Again, it is a great pleasure to be here with you this morning."

RE-REFERRAL OF A SENATE BILL

At this time, Senator King rose on a point of personal privilege and stated as follows:

"Mr. President, I rise on a point of personal privilege.

Yesterday's paper which I had not read before the session, carried a story about West Oahu College indicating no dissenting views to the thought expressed that the Senate's position continued to be the same--in support of West Oahu.

The article is correct, as far as it went and the statement quoted is basically correct, but it was a quirk in timing that led to no questions being raised about continued commitment to West Oahu.

What happened was the Committee met at 9:00 a.m. and at 11:30, we still had not gotten to West Oahu, the two and a half hours being filled with very depressing news about severe cutbacks that the community colleges were being forced to make because of no money—this at a time when we have 18 million dollars CIP projected down the road for West Oahu and at a time at which they were spending over \$6,000 to advertise their courses.

At 11:30 a.m., a phone call indicated that there wasn't a quorum to begin the session unless some of us went down, so we did.

Ten minutes later when I went back up, the hearing was over so that those of us who went down to the session, did not get to ask questions about West Oahu.

The purpose of my rising on this point of special privilege, Mr. President, is simply to indicate that here is one member of the Senate who continues to feel that West Oahu is poor planning policy, poor education policy and poor dollar policy.

Thank you."
