Wednesday, February 9, 1977

The Senate of the Ninth Legislature of the State of Hawaii, Regular Session of 1977, convened at 11:30 o'clock a.m., with the President in the Chair.

The Divine Blessing was invoked by Father Henry F. McCloskey of the Star of the Sea Church, after which the Roll was called showing all Senators present.

The President announced that he had read and approved the Journal of the Fifteenth Day.

Senator R. Wong then rose on a point of personal privilege to speak as follows:

"Mr. President, in yesterday's Honolulu Star-Bulletin, I was quoted as being concerned about a potential loss of State tax revenues of \$100 million a year if the sugar industry should fail.

That, Mr. President, was a misstatement on my part, and I want to take this opportunity to set the record straight.

In 1975, the sugar industry paid about \$10.4 million in direct State taxes and \$2.2 million in real property taxes. When I mentioned the \$100 million figure, I was unconsciously

thinking about the total annual earnings of the 9,000 sugar workers in the State.

Mr. President, I want to thank you for allowing me to clarify this point. $\mbox{"}$
