NINETEENTH DAY

Monday, February 14, 1977

The Senate of the Ninth Legislature of the State of Hawaii, Regular Session of 1977, convened at 11:30 o'clock a.m., with the President in the Chair.

The Divine Blessing was invoked by the Reverend Warren Fujimoto of the Soto Mission, after which the Roll was called showing all Senators present, with the exception of Senator Taira, who was excused.

The President announced that he had read and approved the Journal of the Eighteenth Day.

"Mr. President, I rise on a point of personal privilege.

Last Saturday's issue of the Star

Bulletin printed a letter which referred to a public hearing which was held last week on the marijuana issue. It erroneously implied that this Honorable Body had financed these four mainland experts who had flown in to testify on the decriminalization of marijuana.

I would just like the record to be very clear that there was no State tax money at all. In fact those four people were financed by the National Organization for the Reform of Marijuana Laws. In addition to that, we had several testimonies which were against the bill, so contrary to some of the more dramatic news reports saying that it was weighted on one side, in natural fact it was a well-balanced public hearing just as the others on the same issue have been for the past three years.
