

TWENTY-FOURTH DAY

Tuesday, February 22, 1977

The Senate of the Ninth Legislature of the State of Hawaii, Regular Session of 1977, convened at 11:30 o'clock a.m., with the President in the Chair.

The Divine Blessing was invoked by Father James Habenicht of the Sacred Heart Church, after which the Roll was called showing all Senators present, with the exception of Senator R. Wong who was excused.

The President announced that he had read and approved the Journal of the Twenty-Third Day.

The following introductions were made to the members of the Senate:

Senator Anderson introduced 40 senior citizens from Waimanalo Senior Citizens, together with Mr. Joe Francis, President.
