### THIRTY-SECOND DAY

Friday, March 4, 1977

The Senate of the Ninth Legislature of the State of Hawaii, Regular Session of 1977, convened at 11:30 o'clock a.m., with the President in the Chair.

The Divine Blessing was invoked by Reverend Raymond Lau of the University Avenue Baptist Church, after which the Roll was called showing all Senators present, with the exception of Senator Leopold who was excused.

The President announced that he had read and approved the Journal of the Thirty-First Day.

The Senate reconvened at 11:47 o'clock a.m.

At this time, Senator Yee introduced to the members of the Senate Mrs. Alma Langer and her daughter, Mrs. Ralph Duran, from Minnesota.

Senator Kuroda then introduced 31 fifth and sixth grade students from Hilo Union Elementary School, accompanied by their teachers, Mr. Miyashiro, Mrs. Ells, Mr. Kuhagura, Mrs. Lau and Mr. Fujimoto.

At this time, Senator Ching rose to speak on a point of personal privilege as follows:

"Mr. President,

This morning's newspaper published the reaction of certain members of the Board of Education to a resolution which I and twenty-one other members of this Body have co-sponsored...the article casts dispersion on not only myself but also on the others who co-signed.

Senate Resolution No. 297 pertains to the Board of Education's recent actions on the proposed Makiki Branch Library.

It seems to me, Mr. President, that the reaction of those Board members quoted in the article reflects an attitude bordering upon arrogance. Certainly, it demonstrates a total lack of understanding of the constitutional foundations of our State government.

In effect, it has been said that the Legislature has no right to look into this matter and that it is the sole prerogative of the Board of Education to establish branch libraries wherever and whenever the Board felt moved to do so.

This, Mr. President, is the very point of the resolution my colleagues and I have introduced.

By law and by practice, the development of our library system is incorporated in the Executive budget. The ultimate policy decision, however, rests with the Legislature.

It is, therefore, clearly not only our right but our responsibility to seek information on the basis for any unilateral action that the Board may have taken.

Mr. President, I find the rather cavalier attitude of certain Board members quite disturbing. The resolution does not demand any appearances; no one has suggested issuing subpoenas.

We are not asking anyone to explain his or her vote on the issue.

There is nothing 'presumptuous' about the resolution.

All we are trying to do is to determine the rationale, if there is one, for the Board's extraordinary decision in seeking to establish a new library through an independent process of its own making.

How does the Board propose to finance this project?

Where will the funds come from for renovations to the structure proposed to house the library?

Where will the necessary equipment come from?

Where are the finances for resources to be stocked in the library?

What are the sources to pay for trained personnel to service the library?

These are all legitimate questions for the Legislature to ask.

Mr. President, I think most of us here are familiar with the genesis of this issue. We know the political motivations that gave rise to it in the first place. Our primary concern is that the State library system be developed and administered in an orderly manner.

If the Makiki Library does fit into the orderly scheme of the Department's program, then its proponents should have no difficulty in convincing us of its justification.

I think, however, that this morning's article has only served to strengthen convictions of something else--that it's time to return to an appointed School Board.

Finally, Mr. President, I have been called many things in my political life, and am somewhat inured to unusual characterizations.

For the benefit of those unfamiliar with Chinese history, it should be noted that the Ching Dynasty saw its demise many centures ago. And while it may be flattering, the Ching clan can hardly be described as an empireleast of all with me as Emperor.

Thank you, Mr. President."

Senator King replied, "In connection with the previous speaker's final remarks about 'we all know the genesis of this project', I think the Representatives and Senators in the District were responsible for the genesis of this project, as well as the desires of the people.

Money for the project was put into

the budget adopted by the entire State Legislature".

Senator Taira then rose to speak on a point of personal privilege as follows:

"Mr. President, it seems that when one is down and out with the flu, he gets strange publicity in the newspapers.

First of all, I'd like to advise my colleagues and the public at-large that I am not a landlord. If owning a one-bedroom condominium in Makaha, together with owning your own home, makes me a landlord...then I am a landlord.

Secondly, I see in this morning's paper that I was one of those who failed to sign the resolution that Senator Ching referred to. It seems to be inferred that I was not in accord with the intent of the resolution. Mr. President, I am happy to report to you and to this Body, that this morning I went to the Clerk's office and signed the original of the resolution.

Thank you."

## ADJOURNMENT

At 12:00 o'clock p.m., on motion by Senator Taira, seconded by Senator Anderson and carried, the Senate adjourned until 11:30 o'clock a.m., Monday, March 7, 1977.
