

## THIRTY-THIRD DAY

Monday, March 7, 1977

The Senate of the Ninth Legislature, State of Hawaii, Regular Session of 1977, convened at 11:30 o'clock a.m., with the President in the Chair.

The Divine Blessing was invoked by the Reverend Franklin S.H. Chun of St. Peter's Episcopal Church, after which the Roll was called showing all Senators present.

The President announced that he had read and approved the Journal of the Thirty-Second Day.

Senator Anderson introduced to the members of the Senate forty-three members from the Pauoa Senior Citizens Club.

## HOUSE COMMUNICATIONS

On motion by Senator Taira, seconded by Senator Takitani and carried, S.B. No. 147, entitled: "A BILL FOR AN ACT RELATING TO PUBLIC UTILITIES", having been read throughout, passed Third Reading on the following showing of Ayes and Noes:

Ayes, 25. Noes, none.

At this time, Senator Ching rose and commended the members of the Senate and all staff members for meeting the deadline set for moving all Senate Bills to their last committee.

Senator Anderson rose on a point of information and remarked as follows:

"Mr. President, it's obvious from the number of appropriations bills coming into the Committee on Ways and Means that some of us didn't get notified of the number of millions of dollars we now have to spend."

Senator R. Wong responded that a meeting will be held this evening to discuss the revenue sharing bill and other matters, and that the results of that meeting will be made known to members of the Senate.

Senator Kawasaki then rose on a point of personal privilege and noted his concern over the fact that members of the Senate do not voice their feelings pertaining to some of the legislation when they come up for Second Reading that carry appropriations which are not quite justifiable. He added that many feel that these measures

will not be reported out from the Ways and Means Committee. He continued, "I think that the Chairman of the Ways and Means Committee is subjected to enough pressure. He is the bad guy to enough people in the State here and I think it is awfully unfair for us not to examine the justification of some of these appropriation bills, and then vote according to our conscience. We should save pressure from being put on needlessly on the Chairman of the Ways and Means Committee and his Committee members."

Senator Ching then stated as follows:

"Mr. President, in response to the point that was just raised, I know that there are more measures with appropriations that were not moved out of the respective committees. As a matter of policy decision, whether it is in the area of housing or transportation or health, the committee members saw fit to move the bills to the money committee.

I think that the Chairman of the Committee on Ways and Means and the members of that Committee are well aware of the problems they are going to be faced with. They knew the responsibility when they took on membership of this particular committee and they are going to have to make their decision."

At 12:19 o'clock a.m., the Senate stood in recess until 5:30 o'clock p.m. this afternoon.
