# THIRTY-EIGHTH DAY

#### Monday, March 14, 1977

The Senate of the Ninth Legislature of the State of Hawaii, Regular Session of 1977, convened at 11:30 o'clock a.m., with the President in the Chair.

The Divine Blessing was invoked by Reverend Jerry Appleby of the First Church of the Nazarene, after which the Roll was called showing all Senators present, with the exception of Senator Anderson who was excused.

The President announced that he had read and approved the Journal of the Thirty-Seventh Day.

At this time, Senator Yee introduced to the members of the Senate a group of senior citizens from Laimi Senior Citizens.

In accordance with Article III, Section 16, of the Constitution of the State of Hawaii, the 24-hour notice was given on S.B. No. 758.

Senator O'Conn., for the Committee on Transportation, presented a report (Stand. Com. Rep. No. 386) recommending that Senate Bill No. 485, as amended in S.D. 1, pass Third Reading.

In accordance with Article III, Section 16, of the Constitution of the State of Hawaii, the 24-hour notice was given on S.B. No. 485, S.D. 1, entitled: "A BILL FOR AN ACT RELATING TO RECONSTRUCTED VEHICLES".

Senator O'Connor, for the Committee on Transportation, presented a report (Stand. Com. Rep. No. 387) recommending that Senate Bill No. 1411, S.D. 1, pass Third Reading.

By unanimous consent, action on Stand. Com. Rep. No. 387 and S.B. No. 1411, S.D. 1, entitled: "A BILL FOR AN ACT RELATING TO PREVENTING LITTER FROM TRUCKS", was deferred until Tuesday, March 15, 1977.

ORDER OF THE DAY

### **RE-REFERRAL OF A HOUSE BILL**

The President made the following re-referral of a House Bill that was received on Thursday, March 10, 1977:

House Bill Referred to:

No. 929, H.D. 1 Committee on Consumer Protection, then to the Committee on Judiciary

At 11: 46 o'clock a.m., the Senate stood in recess subject to the call of the Chair.

The Senate reconvened at 12:02 o'clock p.m.

At this time, Senator Leopold rose on a point of personal privilege to speak as follows:

"Mr. President,

On January 26, I introduced Senate Bill No. 167, which was referred to the Senate Committee on Economic Development. It has been thirty-two legislative days since the introduction of that measure.

On February 22, a hearing was held on the bill, where it received wide support. As a matter of fact, the next morning's headline, I believe, said: 'Bureau to Assist Filming is a Must Senate is Told'.

Well, in spite of the testimony in support of the measure...in spite of the fact that you, Mr. President, in your opening day remarks, and the Governor, in his State of the State address, stressed the importance of reaching out aggressively and broadening our economic base...the Chairman of the Senate Committee on Economic Development, a Senator for whom I have a great deal of personal admiration, has apparently decided not to report this measure out of his Committee.

I'd like to read into the record two things. One, the Purpose clause of the bill and second, a letter. The Purpose clause of the bill states as follows: 'The Legislature recognizes the importance...'"

At this time, Senator Ching, rising on a point of order, requested that the former speaker state his personal privilege.

The President then directed Senator Leopold to confine his remarks to the point of personal privilege.

Senator Leopold stated that "as the arbitrary deadline for the movement of bills from this house to the other house is fast approaching, I would like to make a plea for a measure which I feel is of great importance to the people of the State".

Senator Ching replied that "under the guidelines sent out by the chairmen, this does not fall into the category of personal privilege".

Senator Yee then rose to state, "The point of personal privilege is that a bill is being 'iceboxed'. Because he feels very strongly about it, he would like to make a statement on the floor for the record".

Senator Ching then asked to renew his point of order.

The President stated, "I have to agree with the Majority Leader. The question of personal privilege is rather limited, in accordance with the memo I sent out on February 28, 1977".

At 12:05 o'clock p.m., the Senate stood in recess subject to the call of the Chair.

The Senate reconvened at 12:08 o'clock p.m.

At this time, the President again directed Senator Leopold to confine his remarks to the point of personal privilege.

Senator Leopold continued as follows:

"Thank you, Mr. President. As I was stating, I felt that the bill was of such merit that it should have been reported favorably out of the Senate Committee on Economic Development.

After the hearing, I sent a letter, dated February 24, 1977, to the Chairman of the Senate Committee on Economic Development. I'd like to read that letter for the record:

'Following up the public hearing testimony on Senate Bill No. 167, Relating to Media Production, I would like to respectfully request that you either report this measure favorably out of the Senate Economic Development Committee or, alternatively, that you put the guts of Senate Bill No. 167 into Senate Bill No. 55, the short form bill which you introduced, and report this measure out of Committee.'

Copies of the letter were sent to the Republican members of the Senate Committee on Economic Development.

I still have not received a reply to this letter of February 24. When I approached the Chairman of the Committee, he said that he had received my letter, but the Committee would not be moving the bill. He added that he had sent me a letter on the subject. Well, I've never received that letter.

I feel very strongly, as I indicated earlier, that both you, Mr. President, and the Governor of the State have expressed an interest in expanding the economic base of our State. We have to aggressively go out and--by deeds, not rhetoric--take steps to bring in the millions of dollars of revenue and provide jobs that could be provided by this measure.

We heard in the testimony of the Committee that the permit system called for in the bill is something that is needed. Right now, we have a hodge podge situation, where movie producers have to jump around from one agency to another. There is a great deal of confusion and lack of coordination.

Senate Bill No. 167, by the way, Mr. President, is part of the Senate Republican economic development package. I know that the Republican members support this bill.

I feel very strongly that this should be reported out of Committee."

Senator Leopold then stated, "I would like to ask the Chairman of the Senate Economic Development Committee why he did not respond to my letter and, secondly, why he has not reported this measure out of his Committee". At this time, Senator O'Connor rose on a point of order to state:

"Mr. President, this last speaker, who rose on a point of personal privilege, has now twisted the procedure of this Body to a point where we are now engaging in diatribe and debate on the floor of the Senate when there is no such procedure allowed.

I would rise on a point of order and ask that the President rule on the point--the point being that the question, as posed by the last speaker, is out of order and should not be asked nor answered."

The President ruled that the previous speaker's question to the Chairman of the Committee on Economic Development was out of order.

Senator Leopold then moved that Senate Bill No. 167 be recalled from the Committee on Economic Development, seconded by Senator Yee.

At this time, Senator F. Wong rose to speak against the motion as follows:

"Mr. President,

Senate Bill No. 167 was referred to your Committees on Economic Development and Ways and Means.

At the public hearing, the State of Hawaii indicated that the bill was unnecessary and would be costly to administer. Yes, there was overwhelming testimony in favor of a system, as described by the Senator across the aisle. However, the public testimony was in the form of many generalities.

Those of us who are working on a system to cut down the red tape in the bureaucracy that we live in, know that adding another layer of bureaucracy is not going to help us.

Your Committee on Economic Development, in its letter to the Chairman of the Ways and Means Committee, recognized the problems and the potential for this industry. As a result of the budget cuts...we cut more than three percent from many of the State agencies under the jurisdiction of your Committee...with the savings realized, an additional appropriation was made to the Department of Planning and Economic Development for media production. We feel that by doing it in this manner, by incorporating it into the operating budget, the potentials of this industry can best be realized.

Mr. President, we have treated the Republican measure in our Committee with the same fairness as the Majority package bill, also in our Committee. Neither bill was reported out. Both were treated fairly.

The State is committed to some production, and the best way that commitment can be expressed is in the Executive Budget."

At 12: 16 o'clock p.m. the Senate stood in recess subject to the call of the Chair.

The Senate reconvened at 12:24 o'clock p.m.

Senator O'Connor moved that Senate Bill No. 167 be tabled, seconded by Senator Kawasaki.

The President then ruled the motion undebatable.

The motion to table S.B. No. 167, entitled: "A BILL FOR AN ACT RELATING TO MEDIA PRODUCTION", was put by the Chair and, Roll Call having been requested, carried on the following showing of Ayes and Noes:

Ayes, 14. Noes, 10 (Chong, George, Henderson, King, Leopold, Nishimura, Saiki, Soares, Yee and Yim). Excused, 1 (Anderson).

At 12: 34 o'clock p.m., the Senate stood in recess subject to the call of the Chair.

The Senate reconvened at 12:35 o'clock p.m.

Senator Nishimura moved that Senate Bill Nos. 283, 285, 370, 392, 397, 398, 400, 402, 408, 554, 557 and 559 be recalled from the Committee on Judiciary, seconded by Senator Chong.

At this time, Senator Nishimura rose to speak as follows:

"Mr. President,

From time to time, this Chamber has echoed with periodic grumbling and bellyaching that I, as Chairman of the Judiciary Committee, have 'iceboxed' or discriminated against meritorius bills introduced by the Minority members of this Body.

Mr. President, in reviewing the three hundred plus bills referred to the Judiciary Committee, I have discovered that in addition to Senate Bill No. 184, which is scheduled for hearing by the Committee of the Whole this evening, there are other bills of equal import and far reaching consequences ...including some bills considered by the Minority members as their main thrust this legislative session...which your Judiciary Committee has not had time to schedule for hearing or act on within the time schedule established by leadership.

Therefore, Mr. President, I urge that Senate Bill No. 400, introduced by Senator Anderson; Senate Bill No. 398, introduced by Senator George; Senate Bill Nos. 283, 285, 370, 397 and 408, introduced by Senator Henderson; and Senate Bill Nos. 392, 554, 557, 559 and 402, introduced by Senator Yee be recalled from your Judiciary Committee and be considered by the Committee of the Whole this evening, as time permits, following an appropriate motion to waive the 48-hour notice requirement."

Senator Yee then rose to state, "We are very delighted with the number of bills that are being brought on the floor for hearing and action. I certainly endorse the comments of the previous speaker".

At 12:39 o'clock p.m., the Senate stood in recess subject to the call of the Chair.

The Senate reconvened at 12:42 o'clock p.m.

At this time, Senator R. Wong rose to speak against the motion as follows:

"Mr. President,

I can understand why certain pet bills have been kept locked up in other standing committees, but my particular Committee, Mr. President, has bills-probably the most introduced in the State Senate--which deal with money. Many of those bills will not see the light of day, whether they are Republican or Democratic measures.

The simple explanation is that these bills cost money, and we just don't have the money to cover all of them. Therefore, it is the job of my Committee to screen off those bills which we think are costly.

There are many measures in the Ways and Means Committee, which deal with monies benefiting certain special interest groups within the State, that we have attempted to keep back in Committee. If this motion is allowed to pass, then these bills can now become the property of this Body.

I think, Mr. President, what we are doing here shows that the Senate is now in almost total disorganization."

At 1:21 o'clock p.m., the Senate stood in recess until 7:00 o'clock p.m., this evening.

The Senate reconvened at 7:09 o'clock p.m.

At this time, the President directed the Clerk to note the presence of Senator Anderson.

At 7:10 o'clock p.m., Senator O'Connor moved that the Senate resolve itself into a Committee of the Whole to consider Senate Bill No. 184 and for a public hearing on that matter, seconded by Senator Taira and carried. The Senate thereupon resolved itself into a Committee of the Whole with Senator O'Connor as Chairman.

At 11:58 o'clock p.m., the Committee of the Whole rose and the Senate reconvened.
