

THIRTY-NINTH DAY

Tuesday, March 15, 1977

The Senate of the Ninth Legislature of the State of Hawaii, Regular Session of 1977, convened at 12:01 o'clock a.m., with the President in the Chair.

The Divine Blessing was invoked by the Honorable Francis A. Wong, Senator from the Fourth Senatorial District, after which the Roll was called showing all Senators present.

The President announced that he had not read the Journal of the Thirty-Eighth Day, and would report back at a later time.

At 12:04 o'clock a.m., Senator O'Connor moved that the Senate resolve itself into a Committee of the Whole to consider Senate Bill No. 184 and accept more testimony on that matter, seconded by Senator Taira and carried. The Senate thereupon resolved itself into a Committee of the Whole with Senator O'Connor as Chairman.

At 2:08 o'clock a.m., the Committee of the Whole rose and the Senate reconvened.

Senator O'Connor then reported to the Body as follows:

"Mr. President, the Committee of the Whole has agreed by a vote of 14 to 11 to pass Senate Bill No. 184 with the attorneys reviewing the legal language and then preparing a Senate Draft of the bill along with a Committee of the Whole Report for signatures this morning."

At 2:10 o'clock a.m., the Senate stood in recess subject to the call of the Chair.

The Senate reconvened at 2:11 o'clock a.m.

At 2:13 o'clock a.m., the Senate stood in recess until 11:30 o'clock a.m., this morning.

The Senate reconvened at 11:38 o'clock a.m., with all Senators present with the exception of Senator Young, who was excused.
