#### FORTY-THIRD DAY

Monday, March 21, 1977

The Senate of the Ninth Legislature of the State of Hawaii, Regular Session of 1977, convened at 11: 30 o'clock a.m., with the President in the Chair.

The Divine Blessing was invoked by Miss Susan Pelle of the Koolaupoko Baha'i Community, after which the Roll was called showing all Senators present.

The President announced that he had read and approved the Journal of the Forty-Second Day.

At this time, the following introductions were made to the members of the Senate:

Senator Taira introduced forty senior citizens from the Hawaii State Senior Center at Lanakila with their student leader, Mrs. Joyette Kelley; their secretary, Mrs. Faith Osurman and their aide, Mrs. Gladys

Senator Anderson introduced fifty members of the Aiea Lani Senior Citizens Club. Among the group was the great aunt of Senator F. Wong, Mrs. Daisy Wong.

Senator Kuroda then introduced the Honorable Joshua Koshiba of the Palau Legislature. Accompanying him was Mr. Hideo Tangadik from Palau, who is presently a student at the University of Hawaii.

# MESSAGE FROM THE GOVERNOR

A message from the Governor (Gov. Msg. On motion by Senator King, seconded by Senator Saiki and carried, S.C.R. No. 130 was adopted.

Senator King then introduced to the members of the Senate Mr. Henry A. Walker, Jr. She then presented him with a copy of the resolution just adopted.
