#### Tuesday, March 29, 1977

The Senate of the Ninth Legislature of the State of Hawaii, Regular Session of 1977, convened at 4:55 o'clock p.m., with the President in the Chair.

The Divine Blessing was invoked by Reverend Kenjyo Urakami of the Jodo Mission, after which the Roll was called showing all Senators present.

The President announced that he had read and approved the Journal of the Forty-Seventh Day.

I think we do the same here, when we tenure eight people in the Lieutenant Governor's office under civil service.

I would like to adhere to the original request to put four people on civil service, giving the agency flexibility to remove four positions or find new people, if they see fit to do so in the future.

For this reason, I have to vote No on this bill."

Senator R. Wong then rose to speak in favor of the measure:

"Mr. President, in answer to my distinguished colleague from the Fifth Senatorial District, we have been in contact with the Lieutenant Governor relative to the concerns raised by the members of this Honorable Body.

I spoke with him two nights ago, and he indicated to me that his feelings weren't that strong. However, he did feel that his present personnel is a very competent team...some of them have been in Elections about eight years and some three or four years.

It was his feeling that he could buy the justification of making these people permanent employees...and, possibly, take this out of the realm of politics.

Therefore, I urge the members of this Body to vote in favor of the measure."

At 5:55 o'clock p.m., the Senate stood in recess subject to the call of the Chair.

The Senate reconvened at 5:57 o'clock p.m.

Senator Soares moved that the amendment be adopted, seconded by Senator Anderson.

At this time, Senator Soares rose to speak as follows:

"Mr. President, this amendment amends all prior appropriations affecting the West Oahu College. I illustrated in my speech last night about the unnecessary program. I hereby ask all members to vote for the amendment."

The motion to adopt the amendment was put by the Chair and, Roll Call having been requested, failed to carry on the following showing of Ayes and Noes:

At this time, Senator Kawasaki rose to speak on the measure as follows:

"Mr. President, while I am voting Aye on House Bill No. 12, H.D. 2, S.D. 1, I think the fact that we have such a large list of lapsed funds and programs, indicates that perhaps we, in the Legislature, are a little too cavalier about our responsibility of examining budget and program implementation requests.

The fact that these many programs, with these huge amounts of monies, have lapsed, simply indicates to me that the State government was well able to get by without these expenditures and without these programs being implemented."

Senator Chong then rose to speak as follows:

"Mr. President, I would like to

support the former speaker's statements and, also, to commend the Senate Ways and Means Committee for cleaning up potential wastage of tax money.

I voted No on the amendment, even though I was in favor of some of the things in it...because to pass the amendment would have effectively killed this very important bill which, in the long run, will save the taxpayers of the State a lot of money."

Senator Anderson then rose on a point of clarification:

"Mr. President, supporting the amendment would in no way have killed the bill. Supporting the amendment would have included into the bill various programs, totalling some \$8 or \$9 million, previously appropriated for only seventy-six students."

"Mr. President, I had hoped that the election of delegates to this Convention would take place in 1977, not 1978.

I am also concerned about Section 6 of the bill, which states that the amendments proposed by the Convention shall be submitted to the electorate at the General Election in 1978, unless the Convention determines otherwise. It is my hope that the Convention will determine otherwise, so that amendments can be ratified in a special election and reforms, that many of us have been seeking, will take effect at the time of the election.

I would like the Clerk to register my vote as No."

Senator Kawasaki then rose to speak as follows:

"Mr. President, I would like to enter into the record some comments I hope will be taken very seriously by the House and Senate conferees for this Con-Con bill.

I would like very much for the conferees to consider the bill as it emerged from the Committee on Judiciary--specifically, that the number of delegates be limited to fifty-three.

I had the privilege of serving in the 1968 Constitutional Convention. It was my observation that the number of delegates was a little too large and unwieldy. I found, many times, that delegates did not attend sessions and that, literally, only three dozen or so people, out of eighty-six, worked hard in committees to propose amendments to the Constitution.

I would like to remind the conferees, whoever they are going to be...and I assume the Chairman of Ways and Means will be the Chairman of the conferees from the Senate...that the constitutional convention that considered the document which is an insurance to all freedom loving peoples of this world, had only sixty-five delegates, representing thirteen states. They did their work expeditiously. As a matter of fact, when the Constitution of the United States of America was adopted in September 1798, only forty of the delegates were present to sign it. The document has withstood the test of time for almost two centuries...one hundred and ninety years to be exact...with only twenty-six amendments as of this year.

I don't think we can justify one hundred and two delegates to amend a few sections of our State Constitution.

The difference in cost to the taxpayers, between the fifty-three recommended by the Judiciary Committee and the one hundred and two now recommended, would be over a quarter of a million dollars in salaries alone.

In this day and age, when we are talking about saving money to provide human services, I think it behooves the members of the Senate to go into conference with a position of advocating fifty-three delegates who should do their work expeditiously--thereby, saving the taxpayers a quarter of a million dollars.

I am voting Aye, with an admonition to the conferees."

The Board originally was established to nominate to the Governor, the Director of the Intake Service Center. Today, under the amendments in this bill, the Governor will appoint the Director without the advice of the Intake Service Center Advisory Board, and that Director will then operate the overall system.

I am going to vote for this bill, because I believe the placement of the Intake Service Center people is properly under civil service.

However, I would urge all in the future to remember that the Intake Service Center still needs to be placed somewhere within our correctional system. This is something which is still left dangling."

The motion was put by the Chair and carried, and before the vote was announced, Senator O'Connor rose on a point of clarification:

"Mr. President, I understand that anyone who votes No on a bill--and that bill later goes to conference-may not be a member of the Conference Committee. Is that correct?"

The President answered, "That has been the rule".

Senator Anderson rose to state:

"Mr. President, that has not been the rule. The record will reflect that members have been conferees whether they voted Aye or No. They have never been denied that privilege."

Senator O'Connor then requested a ruling of the Chair:

"Mr. President, that has been the rule of this Body ever since I became a member, and we have always abided by it. People who vote No on bills have not been members of the Conference Committee, as they cannot sustain the Senate position.

Since this is the budget, I would like to request a ruling of the Chair before the vote is announced."

The President then stated, "The Chair is not prepared to make a ruling at this time. Research will be made as to what has been done in the past". Senator Soares then rose to state, "I would like to respond to my colleague from the Third Senatorial District".

Senator Ching then rose on a point of order to state:

"Mr. President, I think all of this is not according to the rules. The vote has been taken and it has not been announced.

May we have the vote announced, please, so that other matters can be taken up."

The President then directed the Clerk to announce the vote.

The Clerk announced that H.B. No. 892, H.D. 1, S.D. 1, entitled: "A BILL FOR AN ACT RELATING TO THE STATE BUDGET", having been read throughout, passed Third Reading by not less than two-thirds vote of all the members to which the Senate is entitled, on the following showing of Ayes and Noes:

Ayes, 18. Noes, 7 (Anderson, George, Henderson, Leopold, Saiki, Soares and Yee).

House Bill No. 817, H.D. 1, S.D. 1:

Senator Toyofuku moved that H.B. No. 817, H.D. 1, S.D. 1, having been read throughout, pass Third Reading, seconded by Senator Young.

At this time, Senator King rose on a point of information to inquire if the Chairman of the Committee on Human Resources would yield to a question, to which Senator Toyofuku answered in the affirmative.

Senator King then stated, "The language on Page 4 of the bill is a little confusing to me. It says: 'Election by the employees in the unit involved, and certification by the board of such resulting employee organization shall not be required.' Will the employees be permitted to vote on the merger itself?"

Senator Toyofuku replied, "It is my understanding that the by-laws of each unit of union organizations provide that the membership shall vote on the measure".

The motion was put by the Chair and carried, and H.B. No. 817, H.D. 1, S.D. 1, entitled: "A BILL FOR AN ACT RELATING TO COLLECTIVE BARGAIN-ING IN THE PUBLIC SECTOR AND AMENDING CHAPTER 89, HAWAII REVISED STATUTES", having been read throughout, passed Third Reading on the following showing of Ayes and Noes:

Ayes, 25. Noes, none.

At this time, Senator Anderson rose on a point of personal privilege to speak as follows:

"Mr. President,

I've been in discussions all day long with both Minority and Majority members, concerning the self-imposed deadline that the House and Senate leaderships have agreed to.

It's evidently caused all kinds of problems in moving legislation in a timely manner between the two bodies because of, one, the workload...I understand the House has been in session right around the clock since 10:00 o'clock this morning...understand ably they are tired...and I understand the debate has been lengthy.

The number of bills that we have before us today are certainly complex--in number, in topic, in substance. But, I find it very discouraging when one house works to introduce extremely important legislation, and the other house, somewhat arbitrarily, bottles it up and doesn't keep it in position for conference and further discussion.

For instance, we went through pains to move the capital punishment bill out of this Body...it strained relationships between many of us. There was a full blown public hearing, which I was very proud to participate in--I thought this was democracy really in action. Then the bill goes over to the House and gets bottled up because of the feelings of one committee chairman. This is highly unfair to the bill and to the public--the proponents and the opponents, really.

I notice that the renter's tax credit, an \$8 million package that would benefit people who are paying rent in this State, got bottled up in the House committee, arbitrarily, without any further hearings.

The child care services tax deduction bill got bottled up.

Probably one of the most important bills in this day of unemployment-the economic package that came out of our Economic Development Committee-has not even moved into position to be discussed further in conference. We are in a position now to ask them to move it out as it is written--Senate version or nothing.

Now, I've heard terms all day long...the

bill is tied to personalities...the bill is tied to one industry...the bill is too heavy.

It's really unfortunate that when unemployment is running rampant in our town, the badly needed stimulus is denied even a conference committee...and the Senate sits in disgust.

I'm not saying it should be passed. I'm not saying it should be forced out of the House. But, the bill should be kept in position to be discussed in length and depth with the budget and other bills related to our economy.

We were elected to solve people problems. We were elected to pass legislation that will keep our economy strong and healthy. And to have personalities, committees, pettiness, politics, or partisanships bottle up bills arbitrarily is really, really unfair.

It will be awfully hard to convince the thousands of people who are unemployed--who might go to work if an economic package were passed--that we are not going to put them to work this year because we have a self-imposed deadline between the House and Senate that says we can't consider legislation amended after today. The public pays us for sixty days of work. They could care less about our self-imposed deadlines!

If these measures mean solving problems for the community, if they mean people going to work, if they mean new innovative ideas, then it is incumbent on us to pass them, to experiment...and hope to heaven that people will be put back to work.

How am I going to tell some guy who is unemployed, and trying to pay a mortgage on his house and keep his kids in school, that an economic package, that might have put him back to work in the construction industry, died because we have a self-imposed deadline, or because some committee chairman, or policy committee, decided to kill it this Session because it's too heavy. I personally find that very hard to defend as a politician, as a Senator from my district. I don't think any of you could defend it either.

I've heard some say that because the Chairman of the Economic Development Committee is too close to that particular industry, they are suspicious. Well, if we can't come before this Body, Mr. President, and introduce legislation in our field, in our strength, what do we come for? I wouldn't be much good to this Body if I were to try and initiate legislation in a field where I have no expertise. I come to participate in the areas where I have strengths, as you all have strengths.

You are supposed to help, to participate, to initiate legislation in your particular field. That's a representative form of government. You are supposed to be the specialist, because you are knowledgeable in your field.

We are supposed to keep you honest... there's a check and balance...we are supposed to make sure that one of our group doesn't run away, legislating and introducing legislation for his own special interest group. That's our responsibility.

But to deny legislation because it comes from someone who is in a particular field, is extremely unfair.

This Session, the House of Representatives--because of their factions, fighting and feuding, and new members, or wherever you want to put the blame-has been very, very unfair to this community. I've heard that it's because there are so many new members in the House, and they can't comprehend these heavy bills. Well, that's understandable, but next year will be election year--and that means they won't want to confront these major bills because they are too controversial. The following year there will be a new group of green legislators in the House and in the Senate. The only people getting shortchanged is the public.

I would ask that the Senate leadership continue tonight and tomorrow morning, if necessary, to try and get some of the major legislation in position. It's not our desire to ram legislation down anyone's throat. All we're asking for is a day in court. We're asking for the opportunity to convince our counterparts across the hall that some of these bills have merit, that they are an opportunity to put people back to work.

I'm sure I speak for the Minority when I say that we are willing to go along with extending the deadline if important legislation, for the sake of the public, will emerge from this legislative Body.

Thank you, Mr. President."

Senator Ching then rose to speak as follows:

"Mr. President, I would like to respond to the eloquent Minority Floor Leader. Efforts have been made, starting yesterday, along the lines he has suggested. I think the key to this whole problem is that the deadlines are self-imposed-and whatever is self-imposed can be self-changed.

The offer has already been made that, with the agreement of the two parties to the contract, any deadline we have made can be extended. This message has been passed over to the other body."

Senator R. Wong then rose to speak as follows:

"Mr. President,

I was going to sit here very quietly, but may I respond to the oratory of the Minority Floor Leader.

I find it difficult, Mr. President, to understand the rationale that's been developed on this economic package. I've heard throughout the course of the day a kind of personal link-up between the Chairman of the Economic Development Committee and some members of the Senate in terms of hotel development. Mr. President, I want this Honorable Body to know that in our deliberations in Ways and Means, we did not consider who or what was involved in the industry. Our primary concern was how can we, by some innovative means, put people back to work.

On that basis, Mr. President, I own no hotels, I'm not in the process of planning a hotel, I have not discussed resort development with any developer, and I have not even taken a look at some of the places being suggested for possible hotel development.

My involvement, Mr. President, was a very simple one. I felt that the SCETA program, in terms of a cost benefit factor, was not getting the kind of results expected for an expenditure of \$12 million.

In addition to that, Mr. President, I met with all of the construction unions throughout the State. Most of you know that I've spent a good part of my life with the labor movement, and it concerns me, when I go down to the carpenter's union, the laborer's union, the electrical worker's union, the roofer's union, to find that approximately thirty-five to forty percent of the people who have been employed in the construction industry for the past fifteen to twenty years, are sitting on the bench, trying their best to meet payments and the cost of everyday living.

Mr. President, you know and I know that one of the greatest problems

facing this State is unemployment, pressured by other economic conditions... for example, the fate of sugar, the fate of pineapple, and the fate of military spending, our three out of four basic economic profits in the State.

I want it to be known here and now, Mr. President, that the support of this measure is not based on any personal benefit to me, or the Majority, or even the great number of Senators seated in this Honorable Body.

I hope, Mr. President, that the House will consider our offer, and in their wisdom grant us the opportunity to take this measure to a Conference Committee to have it resolved one way or another.

Mr. President, in all honesty, I want to again commend the Minority Floor Leader for speaking out on the issue...that our approach to solving our great problem of unemployment in the State should be totally non-partisan."

## ADJOURNMENT

At 7:09 o'clock p.m., on motion by Senator Taira, seconded by Senator Anderson and carried, the Senate adjourned until 11:00 o'clock a.m., Wednesday, March 30, 1977.
