

## FIFTY-FOURTH DAY

Wednesday, April 6, 1977

The Senate of the Ninth Legislature of the State of Hawaii, Regular Session of 1977, convened at 11:30 o'clock a.m., with the President in the Chair.

The Divine Blessing was invoked by Reverend Kenneth Ashitomi of the Honolulu Holiness Church, after which the Roll was called showing all Senators present.

The President announced that he had read and approved the Journal of the Fifty-Third Day.

At this time, the following introductions were made to the members of the Senate:

Senator Anderson introduced 35 senior citizens from Hui O'Kahala, together with Mr. Dave Hashimoto, Coordinator.

Senator Ching introduced students representing the YMCA Youth Legislature as follows: Mr. Edward A. Taketa, Youth Governor, Waiakea; Mr. Colin K. Watanabe, House Speaker, Waiakea; Miss Amy S. Reheard, House Clerk, West Oahu; Mr. Karl T. Tao, House Sergeant-at-Arms, Waiakea; Mr. Randy K. Yamashita, House Attorney, Waiakea; Mr. Peter Kubota, Waiakea; and Mr. Phillip Hidalgo, Central.

Senator Kawasaki introduced Mr. Warren Toyama, President, Hawaii Federation of the Blind, and Mrs. James Omvig.

Senator Kawasaki then introduced Mr. James Omvig, stating as follows:

"Mr. President, Mr. James Omvig is Assistant to the Director, National Federation of the Blind. He is from Des Moines, Iowa.

Although Mr. Omvig became blind as a teenager, he attended Drake University, acquired a law degree from Loyola, in Chicago, and worked with the National Labor Relations Board. Since September, 1976, he has been Assistant Director of Training and Development, Iowa Commission for the Blind. He is also Assistant to the President, National Federation of the Blind, a position he holds without compensation.

This gentleman is an inspiration to the visually handicapped. He is like our own Terrance Tom who, as you know, was a blind youth who worked very diligently in the public schools, acquired his law degree

from the University of Hawaii, and then worked in the Public Prosecutor's office.

I was one of a group of legislators invited to the Tenth Annual Banquet of the Hawaii Federation of the Blind. I've had the privilege of listening to eloquent orators...Adlai Stevenson, John Kennedy, Hubert Humphrey...I was very impressed with the inspiring and timely message Mr. Omvig delivered to the visually handicapped of our State, many of whom feel that their handicap is beyond anything they can handle."

The President then directed Senator Kawasaki to escort Mr. James Omvig to the rostrum.

The President welcomed Mr. Omvig as follows:

"Mr. Omvig, being an old Iowa boy myself...having spent four years at Grinnell, which is only about sixty miles from Des Moines...it is my personal pleasure to welcome you to the Senate of the State of Hawaii.

I know you have a message to convey to the members of the Senate and the people of Hawaii."

Mr. James Omvig then addressed the members of the Senate as follows:

"Mr. President, Members of the Senate,

It certainly is a signal honor for me, an Iowan, to be welcomed to Hawaii and to speak before this Honorable Body.

Let me capsulize something of what I said the other night to the blind of Hawaii and the many legislators who were there.

I believe that an idea can be a powerful thing, and it can be a powerful thing whether for good or for bad. So far as those of us who are blind in America have been concerned, the powerful idea about blindness has been destructive, not constructive. We have been saddled with the concept that if we are blind, we are helpless.

The powerful new concept, which has been put forth by the National Federation of the Blind, and which is carried on here in Hawaii by Warren Toyama and others like him, is that we who are blind are ordinary people. We are capable human beings. If

we have the right kind of training and if we have real opportunity, then blindness literally can be reduced to the level of a physical nuisance. So far as I'm concerned, my blindness is no more than a nuisance, or inconvenience.

I see blindness, though, and the problems connected with blindness, in a different light. And here, again, is where an idea can be a powerful thing. So far as Mr. Toyama and I, and others like us, are concerned, those of us who are blind constitute a minority group. The problem which is connected with our blindness is not due to the physical facts of blindness, but rather it is due to what we have thought... what we as blind people have believed... what society has believed about us. We have thought that we could not achieve. Society has thought that we could not achieve. Therefore, we have not achieved.

The concepts now being put forward by the National Federation of the Blind are purely to the contrary. We now know that we are a minority group. We have a social problem which can be solved. We want to live in the world. We want to participate in the world. And, in fact, we will live in the world, we will participate in the world.

The National Federation of the Blind is not an organization or agency speaking for the blind. The National Federation of the Blind is the blind speaking for the blind, in our common voice.

Let me just end with these two things. I think, in the past, anyone who criticized someone serving blind people would be regarded as some kind of troublemaker, a radical, a rabblrouser, because it was almost sacrosanct to serve the blind. Everybody wants to serve the blind. But we are now at a point in the history of the United States where we who are blind recognize that sometimes the services provided to us have not been constructive-- rather, they have been of that destructive idea.

We now would put forward the constructive approach that we can and will speak for ourselves. That we can participate. That will necessarily mean that we, as blind people, will sometimes criticize the very agencies, which have been created by the government of the United States and the various state governments, that provide services to us. But I think we should not regard that as a bad thing. We should regard that as a good and constructive thing, since, as the consumers of services,

we should have the right to have some say as to what kind of services those services will be.

Let me simply close with this. Those of us of the National Federation of the Blind who recognize our new concepts, are willing to dream. We are willing to work hard toward first class citizenship and toward equality in our society. We are willing to put forward effort.

What it comes down to, I suppose, is simply this: Rather than be given a quarter, we would like the opportunity to earn a dollar.

There is more involved here than we realize... as Mr. Scrooge, of Dickens' Christmas Carol, would say, 'This is a humbug resolution'.

I would like to have this resolution, if possible, held in abeyance until next session. We can then clarify very clearly what we want to establish as a standard for the Channel 11 staff to follow.

For this reason, I would ask the members of this Senate to vote No."

Senator Chong then rose to speak in favor of the resolution:

"Mr. President, all this resolution does is establish a policy, so that the public broadcasting people can begin to look at their programming more thoughtfully.

It is a well known fact that certain

terms, which have been used unconsciously, tend to denigrate and make women, or men, subconsciously feel inferior. This does not make for a healthy population, especially when such terms affect the young people of our State.

I really don't think it would be too much of a bother for the people at KHET to look at this area and develop some policies for us."
