Tuesday, April 12, 1977

The Senate of the Ninth Legislature of the State of Hawaii, Regular Session of 1977, convened at 11: 30 o'clock a.m., with the President in the Chair.

The Divine Blessing was invoked by the Reverend Bill Tipton of the First Baptist Church of Honolulu, after which the Roll was called showing all Senators present with the exception of Senators R. Wong and Young, who were excused.

The President announced that he had read and approved the Journal of the Fifty-Sixth Day.

At this time, the following introductions were made to the members of the Senate:

The Senate reconvened at 8: 27 o'clock p.m.

At this time, Senator R. Wong rose on a point of personal privilege and stated as follows:

"Mr. President, this evening an article appeared in the Honolulu Star Bulletin which made reference to the Senate's position in the conference committee meeting held last evening.

Mr. President, I take exception to that article because I think it's

a very bias type of reporting. I was very much surprised at the kind of information that was conveyed to the general public by the media by Mr. Gregg Kakesako, who is the staff writer for the Star Bulletin here at the Capitol.

The gist of the article, Mr. President, pointed out to the fact that the Senate was favoring developers and hotel resort developers.

Mr. President, as you have known through the past session and through much agony in this honorable body, I have never been a real advocate of the hotel industry. Contrary to that, I have tried unsuccessfully to push a tourist tax through the legislature for the past ten years. My feeling in this matter is that the primary purpose of the 'push' in the conference committee deals with economic stimulation for this State and the providing of jobs as the number one priority of your Senate. If one were to read the article this evening, one would come away with the impression that the purpose of the Senate was to help hotel owners and developers and the contractors in general in this

To the first, I would say that I am not a developer and I am not pro-hotel development in the State.

Secondly, with reference to the construction, yes, I am a supporter of the construction industry because today at least 35% of our total construction laboring force is without work. I think the series of bills, Mr. President, as presented by our colleague, the Honorable Francis Wong, Chairman of the Committee on Economic Development represents an innovative idea for solving the number one problem for the State of Hawaii, which is unemployment.

Mr. President, I am very saddened that in our deliberations in the conference committee, the House did not even take the time to position these measures for a full and lengthy discussion which would result in the passage of these measures in the House.

I want to state for the record, Mr. President, that in its proposal to the House last evening, your Committee on Ways and Means did not intend that the primary purpose was to put money in the pockets of developers and to show that we were not interested at all in the matter of unemployment in the State.

Mr. President, the article does not mention that with the passage

of some of the measures contained in this economic package, that a single job would be created. I think this is a disservice to the citizens of the State and to the members of this honorable body.

Mr. President, I take serious objection to this article. Again I mention, that it is totally bias and totally unobjective, in terms of solving the problems of this State, and, pursuant to your message to this honorable

body on opening day, the major concern of the State today is unemployment.

Thank you very much, Mr. President."

ADJOURNMENT

At 8: 32 o'clock p.m., on motion by Senator Taira, seconded by Senator Anderson and carried, the Senate adjourned until 11: 30 o'clock a.m., on Wednesday, April 13, 1977.
