SIXTIETH DAY

Friday, April 15, 1977

The Senate of the Ninth Legislature of the State of Hawaii, Regular Session of 1977, convened at 11:22 o'clock a.m., with the President in the Chair.

The Divine Blessing was invoked by Reverend Melvin Walter of the First Baptist Church-Windward, after which the Roll was called showing all Senators present, with the exception of Senator Saiki who was excused.

The President announced that he had read and approved the Journal of the Fifty-Ninth Day.

MESSAGE FROM THE GOVERNOR

A message from the Governor (Gov. Msg. No. 468), transmitting an Executive Order providing for an extension of the 1977 Session of the Ninth Legislature as follows:

"EXECUTIVE ORDER

WHEREAS, Section 11, Article III of the Constitution of the State of Hawaii, provides that an extension of not more than fifteen days of any session may 'be granted by the presiding officers of both houses at the written request of two-thirds of the members to which each house is entitled or may be granted by the governor'; and

WHEREAS, said Section 11 further provides that 'Saturdays, Sundays, holidays and any days in recess pursuant to a concurrent resolution shall be excluded in computing the number of days of any session'; and

WHEREAS, the governor has been requested to grant an extension and it appears that such an extension is necessary;

NOW, THEREFORE, I, GEORGE R. ARIYOSHI, Governor of Hawaii, pursuant to the power vested in me by Section 11, Article III of the Constitution of the State of Hawaii, do hereby extend

the 1977 regular session of the Ninth Legislature of the State of Hawaii for a period of forty-eight (48) hours, following 12:00 midnight, April 15, 1977, but excluding Saturday and Sunday, pursuant to Section 11, Article III of the Constitution of the State of Hawaii.
