Tuesday, April 19, 1977

The Senate of the Ninth Legislature of the State of Hawaii, Regular Session of 1977, convened at 12:17 o'clock a.m., with the President in the Chair.

The Divine Blessing was invoked by Mrs. Linda Cravalho of St. Anthony's Church, after which the Roll was called showing all Senators present, with the exception of Senators Leopold and Yee who were excused.

The President announced that he had not read the Journal of the Sixty-First Day, and would report back at a later time.

CONFERENCE COMMITTEE REPORTS

Senator R. Wong, for the Committee on Conference on the disagreeing vote of the House to the amendments proposed by the Senate to House Bill No. 2, H.D. 1, presented a report (Conf. Com. Rep. No. 47) recommending that H.B. No. 2, H.D. 1, S.D. 1, as amended in C.D. 1, pass Final Reading.

In accordance with Article III, Section 16, of the Constitution of the State of Hawaii, the 24-hour notice was given on the Final Reading of H.B. No. 2, H.D. 1, S.D. 1, C.D. 1, entitled: "A BILL FOR AN ACT MAKING APPROPRIATIONS FOR JUDICIARY PROGRAM EXPENDITURES AND FOR IMPROVEMENTS FOR THE FISCAL BIENNIUM JULY 1, 1977 TO JUNE 30, 1979, AND AUTHORIZING THE ISSUANCE OF BONDS".

Senator R. Wong, for the Committee on Conference on the disagreeing vote of the House to the amendments proposed by the Senate to House Bill No. 5, H.D. 2, presented a report (Conf. Com. Rep. No. 48) recommending that H.B. No. 5, H.D. 2, S.D. 1, as amended in C.D. 1, pass Final Reading.

In accordance with Article III, Section 16, of the Constitution of the State of Hawaii, the 24-hour notice was given on H.B. Senator F. Wong then stated that the amendment made by the House was to "clarify the title".

The motion was put by the Chair and carried, and the Senate agreed to the amendments proposed by the House to Senate Concurrent Resolution No. 28, S.D. 1, and S.C.R. No. 28, S.D. 1, H.D. 1, entitled: "SENATE CONCURRENT RESOLUTION REQUESTING HAWAII'S CONGRESSIONAL DELEGATION TO URGE AND SUPPORT THE CONTINUATION OF FEDERAL SUBSIDIES FOR AMERICAN CRUISE SHIP FLEETS", was finally adopted.

At this time, Senator Chong moved that the Senate agree to the amendments proposed by the House to Senate Concurrent Resolution No. 93, S.D. 1, and that S.C.R. No. 93, S.D. 1, H.D. 1, be finally adopted, seconded by Senator Takitani.

Senator Chong then stated that the House amended the measure "very slightly, by changing the word 'family' to 'household' and by adding 'each State agency' to the final 'Be It Further Resolved' clause".

MESSAGE FROM THE GOVERNOR

"EXECUTIVE ORDER

WHEREAS, SECTION 11, Article
III of the Constitution of the State of
Hawaii, provides that an extension
of not more than fifteen days of any
session may 'be granted by the presiding
officers of both houses at the written
request of two-thirds of the members
of which each house is entitled or
may be granted by the governor';
and

WHEREAS, pursuant thereto the governor extended the 1977 regular session of the Ninth Legislature for a period of forty-eight hours, excluding Saturday and Sunday, to 12:00 midnight, April 19, 1977; and

WHEREAS, it appears that a further extension is necessary in the public interest;

NOW, THEREFORE, I, GEORGE R. ARIYOSHI, Governor of Hawaii, pursuant to the power vested in me by Section 11, Article III of the Constitution of the State of Hawaii, do hereby further extend the 1977 regular session of the Ninth Legislature of the State of Hawaii for a period of eleven (11) hours following 12:00 midnight, April 19, 1977.
