FIRST DAY

Monday, May 9, 1977

The Senate of the Ninth Legislature of the State of Hawaii, Special Session of 1977, was called to order at 10:00 o'clock a.m., by Senator John T. Ushijima, President of the Senate, in accordance with the Proclamation issued by Governor George R. Ariyoshi on May 5, 1977, as follows:

SECOND DAY

Tuesday, May 10, 1977

The Senate of the Ninth Legislature of the State of Hawaii, Special Session of 1977, convened at 9:00 o'clock a.m., with the President in the Chair.

The Divine Blessing was invoked by Chaplain Ervin D. Ingebretson of the United States Navy, 14th Naval District, after which the Roll was called showing all Senators present with the exception of Senators F. Wong and Young who were excused.

MESSAGE FROM THE GOVERNOR

A message from the Governor (Gov. Msg. No. 2) transmitting the collective bargaining net additional costs to be incorporated into a legislative measure, noting that the estimates represent all cost items negotiated and ratified by bargaining Units 1, 2, 3, 4, 6, 7, 8, 9, 10 and 13 for FY 1977-78 and FY 1978-79, which reads as follows:

A proviso, similar to that proviso which was designated as Section 83, Part III, House Bill No. 892, C.D. 1, Regular Session 1977, which was to authorize the use of incremental and longevity salary increases to fund collective bargaining cost items, needs to be incorporated into the General Appropriation Act of 1977. The proviso should read as follows:

Provided, that the following sums in Part II appropriated for incremental and longevity salary increases for employees of the State of Hawaii are authorized to be used to fund cost items in collective bargaining agreements ratified for bargaining units 1, 2, 3, 4, 5, 6, 7, 8, 9, 10 and 13 for the fiscal biennium 1977-79:

STANDING COMMITTEE REPORTS

"Mr. President, before we act on this bill and the ones that follow, I would like the Journal to note that these bills, Senate Bill Nos. 1 to 5, are similar to and in fact based upon bills which were under consideration by the Legislature during the Regular Session of 1977.

In the course of the Regular Session, the earlier versions of these bills received public hearings and were fully deliberated upon by the Legislature. Ample opportunity for public input was provided and the Legislature had more than adequate opportunity to become familiar with the contents of these bills.

Now, these bills have been re-introduced to comply with the requirements of the Special Session. Our actions on these bills should be considered as the final steps of the actions begun during the Regular Session on their earlier versions.

FOURTH DAY

Thursday, May 12, 1977

The Senate of the Ninth Legislature of the State of Hawaii, Special Session of 1977, convened at 9:00 o'clock a.m., with the President in the Chair.

The Divine Blessing was invoked by Mr. Bradley Chow of the Campus Crusade, after which the Roll was called showing all Senators present with the exception of Senators Hara, F. Wong and Young who were excused.

The President announced that he had read and approved the Journal of the Third Day.

STANDING COMMITTEE REPORTS

Senator Yamasaki, for the Committee on Legislative Management, presented a report (Stand. Com. Rep. No. 7), informing the Senate that Standing Committee Report Nos. 8 to 23 have been printed and are ready for distribution.

On motion by Senator Yamasaki, seconded by Senator Henderson and carried, the report of the Committee was adopted.

Senator R. Wong, for the Committee on Ways and Means, presented a report (Stand. Com. Rep. No. 8), recommending that House Bill No. 1 pass Second Reading and be placed on the calendar for Third Reading.

Senator R. Wong moved that the report be adopted and that H.B. No. 1 pass Second Reading and be placed on the calendar for Third Reading, seconded by Senator Yamasaki.

Senator Soares then rose to speak for the measure as follows:

"Mr. President, I rise to speak in favor of the budget with some reservations that I would like to record.

In February when we passed the operating budget, we made attempts to amend the budget dealing with the West Oahu Campus, the Medical School and the Law School. At that particular time, I raised serious questions on the possibility of our trying to be 'all things to all people' with limited resources. I raised the question also of the need to review these programs to be absolutely sure that we had followed our need to take care of our resources and to be sure that we could cover the cost of these three programs.

Since that time, Mr. President, the State collections are substantially down, and, if the trend continues, another round of budget restrictions may be in the offing. I notice that we had taken our plan at 7.0, 10.1 and 10.4 and at this time, the figures show that tax collections for the first ten months of this fiscal year is 3.4. Now I wonder, Mr. President, how in the world are we going to make the 7.0, 10.1 and 10.4.

In mid-April, the administration told us that we have \$13 million in extra revenues to plug into a two-year budget. This projection was made following an analysis of the inflation rate.

Also, Mr. President, in a letter to Representative Jack Suwa, Governor Ariyoshi projected that revenues may rise over the next fifteen months anywhere from \$13 million to \$20 million, again reflecting new appraisals of inflation. As far as I'm concerned, these are concerns that raise the eyebrows as to whether we have a financial plan for this budget before us this morning.

I raise these questions for the record, Mr. President, because I feel that between now and the next session, it will be incumbent upon us to work with our Ways and Means Chairman and, in the case of the three programs that I mentioned, the Higher Education Committee Chairman, to review the cost analysis, the cost benefit ratio and to be absolutely sure that we are responsible in our figuring of the financial plan and of our projections for the next two years.

Thank you, Mr. President."

on these bills should be considered as the final steps of the actions begun during the Regular Session on their earlier versions.

Therefore, Mr. President, I urge the members of the Senate to vote in favor of these bills presently before us.

Thank you, Mr. President."

"Before we adjourn sine die, I believe some remarks may be in order from the Chair to make clear, for the public record, the position and actions taken by the Senate this year.

First, it should be noted that even in the judgment of objective outside observers, notably the editorial comment in our daily newspapers, the output of our Regular Session has been rated as one of respectable productivity. Indeed, our work has been well tuned to public expectations.

While not especially dramatic or glamorous in terms of public appeal, the legislation we have

passed is important to the continued stability of our basic institutions and for general progress throughout our State.

But to me, the most impressive characteristic of the Senate this year has been your clear demonstration of public responsibility.

At the outset, we acknowledged a need to respond positively to our nagging problems of unemployment by developing a program of economic recovery.

The Senate clearly demonstrated its sense of responsibility by taking early action in holding hearings and passing legislation designed to inject fresh stimulus across our economic base.

That we have been on the right track was reaffirmed recently by the Chairman of the President's Council of Economic Advisers who spoke before the convention here of the American Society of Newspaper Editors.

In outlining directions the Council is recommending to breathe new life into the national economy, the Chairman described a program that closely parallels legislation we have advocated.

Our failing, it seems, is that we are a bit ahead of the times.

But your sense of responsibility was most clearly demonstrated in the stress of pressures that arose during and immediately following the close of the Regular Session.

As individuals and as a Body, you have conducted yourselves with admirable restraint. The patience and prudence you have exhibited contrasts sharply with the behavior of others.

It is singularly notable that none of the members of this Body has taken on the role of the lady who 'doth protest too much!'

Because of the Senate's deportment, we can return next year with a renewed sense of dedication, laying aside our troubles this year, to concentrate on the job of shaping a stronger set of legislative programs to meet Hawaii's needs.

To each of you, the Chair expresses its mahalo for a job well done."

At 9:17 o'clock a.m., the Senate stood in recess subject to the call of the Chair.

The Senate reconvened at 9:19 o'clock a.m.

The President then appointed Senators Ching, Taira and Yee as a Committee to inform the House of Representatives that the Senate stood ready to adjourn sine die.

Pursuant to Section 17 of Article III of the Constitution of the State of Hawaii, I am returning herewith Senate Bill No. 1, First Special Session of 1977, entitled, 'A Bill for an Act Relating to Capital Improvement Projects and Authorizing the Issuance of Bonds.'

The purposes of this bill are to make appropriations for certain capital improvement projects and to authorize the issuance of bonds to fund those projects.

While the purpose and intent of the bill as a whole have merit, I find two of the items in Senate Bill No. 1 to be objectionable. These are:

1. Item III. E. 52., at page 30 of the bill, which appropriates \$125,000 for 'Plans and construction to provide musical instruments for the band' at Jarrett Intermediate School, Oahu.

The subject matter of this bill is capital improvement projects. As this item is not germane to the subject of the bill, its inclusion in the bill violates the subject-title requirement of Article III, Section 15 of the State Constitution.

2. Item III. E. 94., at page 35 of the bill, which appropriates \$190,000 for 'Kalaheo High School, Oahu --- Supplementary funds for gymnasium'.

This item duplicates the appropriation of \$190,000 made by the preceding item (Item III. E. 93, at page 35 of the bill) for the same purpose.

For the foregoing reasons, I am returning Senate Bill No. 1, First Special Session 1977, with my objections to those two items.

SCRep. 1 Legislative Management

Informing the Senate that Gov. Msg. No. 2, S.B. Nos. 1 to 5 and Stand. Com. Rep. Nos. 2 to 6 have been printed and are ready for distribution.

SCRep. 2 Ways and Means on S.B. No. 1

The purpose of this bill is to appropriate or authorize, as the case may be, funds for the financing of general public improvements for the fiscal year 1977-78.

The projects herein contained have been developed to accommodate current capital improvement requirements throughout the state. Input for these projects have been received by the legislature from state and county officials, community organizations and members of the general public. Appropriations are provided for state and county projects, including parks and recreational facilities, highway improvements, medical and educational facilities.

Compared to prior years, the number of projects and the total amount appropriated for general public improvements have been reduced. This reduction is in line with the legislature's recognition of the state's debt ceiling, the rising debt service costs, and our continuing attempt to control such costs.

Essentially, this bill is similar to S. B. No. 3, S.D. 1, H.D. 1, C.D. 1 which was fully considered by the legislature during the regular session of 1977.

Your Committee on Ways and Means is in accord with the intent and purpose of S. B. No. 1 and recommends that it pass Second Reading and be placed on the calendar for Third Reading.

SCRep. 3 Ways and Means on S.B. No. 2

The purpose of this bill is to give the state post-secondary education commission the authority to promulgate rules and regulations as may be required from time to time to enable the state to participate in certain federally funded programs available to post-secondary institutions.

This bill also appropriates \$260,000, including \$10,000 for temporary help, to be administered by the commission for the purposes of the federal state student incentive grant program. This appropriation is contingent upon the receipt of federal funds.

This bill is similar to S.B. No. 47, S.D. 2, H.D. 2 which was fully heard and considered by the legislature during the regular session of 1977.

Your Committee on Ways and Means is in accord with the intent and purpose of S.B. No. 2 and recommends that it pass Second Reading and be placed on the calendar for Third Reading.

Signed by all members of the Committee.

SCRep. 4 Ways and Means on S.B. No. 3

The purpose of this bill is to provide low and medium income renters with a state income tax credit of \$20 multiplied by the number of exemptions to which he or she is entitled.

The tax credit would apply to any renter whose adjusted gross income was \$20,000 a year or less and who paid more than \$1,000 in rent for the taxable year. Persons sixty-five years of age or older would be able to claim a double tax credit. This bill will provide tax relief for many of the state's 120,000 renters.

This bill is similar to S.B. No. 1305, S.D. 1 which was passed by the Legislature during the regular session of 1977. However, that measure did not have an effective date section. In order to preclude any possible legal ambiguity which may arise as a consequence to that omission, this bill - with an effective date section - has been

introduced and the Governor has been requested to veto the earlier measure.

Your Committee on Ways and Means is in accord with the intent and purpose of S. B. No. 3 and recommends that it pass Second Reading and be placed on the calendar for Third Reading.

SCRep. 5 Ways and Means on S.B. No. 4

The purpose of this bill is to establish a crime commission composed of representatives of the population of the state, which will study, review, and make recommendations in the crime control area.

Your Committee finds that crime adversely affects every person in the state, and that all steps necessary to prevent crime should be taken. One preventive measure is to secure public input into determining the ways in which crime can be controlled. The establishment of a crime commission, therefore, for such a purpose, is appropriate to the ultimate goal of controlling crime.

The sum of \$100,000 is appropriated by this bill to support and facilitate the work of the commission.

This bill is similar to S.B. NO. 1308, S.D. 2, H.D. 1, C.D. 1 which was fully heard and considered by the legislature during the 1977 regular session.

Your Committee on Ways and Means is in accord with the intent and purpose of S.B. NO. 4 and recommends that it pass Second Reading and be placed on the calendar for Third Reading.

SCRep. 6 Ways and Means on S.B. No. 5

The purpose of this bill is to add a new chapter to the Hawaii Revised Statutes which shall institute a litter control program for the state of Hawaii.

Your Committee finds that this bill represents a major commitment by the state to attain a litter-free environment in Hawaii, an environment which will enhance the visual appearance of our state and which will foster pride and dignity among our people.

The sum of \$300,000 is appropriated for the implementation of this bill.

This bill is similar to S.B. No. 1464, S.D. 2, H.D. 2, C.D. 1 which was fully heard and considered during the 1977 regular session of the legislature.

Your Committee on Ways and Means is in accord with the intent and purpose of S.B. No. 5 and recommends that it pass Second Reading and be placed on the calendar for Third Reading.

SCRep. 7 Legislative Management

Informing the Senate that Stand. Com. Rep. Nos. 8 to 23 have been printed and are ready for distribution.

SCRep. 8 Ways and Means on H.B. No. 1

The purpose of this bill is to provide appropriations for the fiscal biennium July 1, 1977 to June 30, 1979 and authorize the issuance of bonds.

Essentially, this bill is similar to H. B. No. 892, H.D. 1, S.D. 1, C.D. 1 which was fully heard and considered by the legislature during the regular session of 1977. Certain discrepancies and errors which were discovered in that earlier measure have been corrected in this bill, various language changes have been made for greater clarity and a number of other minor adjustments have been made. The major addition to this bill is a \$2,000,000 authorization for the acquisition of St. Francis Convent School in fiscal year 1978-79. Also added is a \$25,000 per year appropriation for PED 130 for improving DPED's MIS

including refinement of the econometric model for revenue forecasting.

In implementing this bill, the agencies of the executive branch are directed to review the various committee reports associated with H. B. No. 892, H.D. 1, S.D. 1, C.D. 1. These contain the expressions of legislative intent, interest and concern which were ultimately resolved in the decisions reflected by this budget bill. Wherever applicable, the agencies should be guided by these reports in interpreting legislative intent.

Your Committee on Ways and Means is in accord with the intent and purpose of H. B. No. 1 and recommends that it pass Second Reading and be placed on the calendar for Third Reading.

SCRep. 9 Ways and Means on H.B. No. 2

The purpose of this bill is to appropriate funds to the judiciary for the 1977-79 fiscal biennium and to authorize capital improvement projects for the judiciary.

This bill is essentially the judiciary's requested budget adjusted for salary turnover savings, deletion of non-essential positions and other minor adjustments. With respect to the judiciary's requested capital improvement projects, certain funds for construction have been rescheduled to bring them more closely in line with the actual planned construction periods when they will be needed.

This bill should provide adequate fiscal resources to meet the judiciary's needs for the upcoming biennium.

This bill is similar to H. B. No. 2, H.D. 1, S.D. 1, C.D. 1 which was fully heard and considered by the legislature during the regular session of 1977.

Your Committee on Ways and Means is in accord with the intent and purpose of H. B. No. 2 and recommends that it pass Second Reading and be placed on the calendar for Third Reading.

SCRep. 10 Ways and Means on H.B. No. 3

The purpose of this bill is to provide for a constitutional convention to be held beginning July 5, 1978.

The constitutional convention is being planned pursuant to the mandate of the voters at the general election of 1976. It is hoped that the convention will develop worthwhile and meaningful revisions to the existing constitution which will make it a stronger, more up-to-date document to guide Hawaii in the years ahead.

Under the provisions of this bill, a total of 102 delegates will be elected at a special election on May 20, 1978, such delegates apportioned among the representative districts of the state according to special constitutional convention districts.

The bill appropriates funds for the expenses of the convention, for the election of delegates and for other convention-related expenses. A total of \$2,066,099 is herein provided.

This bill is similar to H. B. No. 28, H.D. 2, S.D. 1, C.D. 1 which was fully heard and considered by the legislature during the regular session of 1977.

Your Committee on Ways and Means is in accord with the intent and purpose of H. B. 3 and recommends that it pass Second Reading and be placed on the calendar for Third Reading.

SCRep. 11 Ways and Means on H.B. No. 4

The purpose of this bill is to further amend Act 151, Session Laws of Hawaii 1975, which established the state program for the unemployed, and to extend the program through June 30, 1978.

It is hoped that the economic outlook for the state will improve during the forthcoming

fiscal year and that the unemployment rate will concomitantly go down, thus obviating the continued necessity for this program. In the meanwhile, the continued operation of the program will give short-term employment to many people while providing also for improved public services.

An appropriation of \$13 million is provided for the implementation of this bill.

This bill is similar to H. B. 137, H.D. 2, S.D. 2, C.D. 1 which was fully heard and considered during the 1977 regular session of the legislature.

Your Committee on Ways and Means is in accord with the intent and purpose of H. B. No. 4 and recommends that it pass Second Reading and be placed on the calendar for Third Reading.

Signed by all members of the Committee.

SCRep. 12 Ways and Means on H.B. No. 5

The purpose of this bill is to provide funds for negotiated collective bargaining cost items as follows:

1. for unit 1, blue collar non-supervisory employees, for fiscal year 1976-77. Funds for this agreement have also been provided through fiscal biennium 1977-79. Provisions have also been made for salary increases and other adjustments for employees excluded from unit 1.
2. for the new agreements negotiated for units 1, 2, 3, 4, 5, 6, 7, 8, 9, 10 and 13 for the fiscal biennium 1977-79. Provisions have also been made for salary increases and other adjustments for officers and employees excluded from the foregoing units.

This bill represents approval by the legislature of these negotiated agreements.

This bill is similar to H. B. No. 5, H.D. 2, S.D. 1, C.D. 1 which was fully heard and considered by the legislature during the 1977 regular session.

Your Committee on Ways and Means is in accord with the intent and purpose of H. B. No. 5 and recommends that it pass Second Reading and be placed on the calendar for Third Reading.

Signed by all members of the Committee.

SCRep. 13 Ways and Means on H.B. No. 6

The purpose of this bill is threefold, as follows;

1. to allow the department of agriculture flexibility in setting interest rates for all direct farm loans by setting the maximum interest rate to the going prime rate;
2. to provide for a low-interest loan program for independent sugar growers; and
3. to make an appropriation of \$1,500,000 for the loans to independent sugar growers.

It is your Committee's hope that this loan program will be successful in providing interim relief to independent sugar growers until such time as the sugar industry's outlook improves.

This bill is similar to H. B. 180, S.D. 1, C.D. 1 which was fully heard and considered by the legislature during the regular session of 1977.

Your Committee on Ways and Means is in accord with the intent and purpose of H. B. No. 6 and recommends that it pass Second Reading and be placed on the calendar for Third Reading.

Signed by all members of the Committee.

SCRep. 14 Ways and Means on H.B. No. 7

The purpose of this bill is to sustain the momentum generated by the aquaculture planning program by insuring that immediate actions will be initiated to encourage and promote commercial development of aquaculture in Hawaii and to undertake the culture of species with potential for Hawaii.

It is also the purpose of this bill to qualify Hawaii for participation in federally assisted programs and projects in such federal funds as may become available.

This bill appropriates \$672,228 for operating costs and \$138,300 for capital investment costs for the implementation of the aquaculture program.

This bill is similar to H. B. No. 1713, H.D. 2 which was fully heard and considered by the legislature during the 1977 regular session.

Your Committee on Ways and Means is in accord with the intent and purpose of H. B. No. 7 and recommends that it pass Second Reading and be placed on the calendar for Third Reading.

Signed by all members of the Committee.

SCRep. 15 Ways and Means on H.B. No. 8

The purpose of this bill is to increase the public employer's monthly contribution to the health fund's dental plan from \$3.26 to \$3.74 for each child under age 19, in order to maintain the current level of benefits for the children of state and county employee-beneficiaries enrolled for dental benefits.

An appropriation of \$354,000 is provided to fund the state's share of the anticipated 15% increase in dental insurance premiums for the 1977-79 biennium.

This bill is similar to H. B. No. 1175 which was fully heard and considered during the 1977 regular session of the legislature.

Your Committee on Ways and Means is in accord with the intent and purpose of H. B. No. 8 and recommends that it pass Second Reading and be placed on the calendar for Third Reading.

Signed by all members of the Committee.

SCRep. 16 Ways and Means on H.B. No. 9

The purpose of this bill is to authorize changes in the funding designation of certain capital improvement project authorizations contained in Acts 195 and 197, Session Laws of Hawaii 1975, as amended, from general revenue fund source to general obligation bond fund source. The funding changes recommended in this bill will make available \$28,362,000 in general revenue funds and authorize this amount in general obligation bond funds.

The funding changes proposed by this bill will help facilitate the implementation of the specified projects.

This bill is similar to H. B. No. 1292, H.D. 1 which was fully considered by the legislature during the regular session of 1977.

Your Committee on Ways and Means is in accord with the intent and purpose of H. B. No. 9 and recommends that it pass Second Reading and be placed on the calendar for Third Reading.

Signed by all members of the Committee.

SCRep. 17 Ways and Means on H.B. No. 10

The purpose of this bill is to appropriate moneys out of the general revenues of the state for the payment of certain tax refunds, judgments and settlements, and other miscellaneous claims against the state.

This bill is similar to H. B. No. 10, H.D. 1, S.D. 2 which was fully heard and considered by the legislature during the regular session of 1977. The major change in this bill is the addition of an appropriation of \$2,611.94 for payment of a judgment against the state in favor of Paul B. Bailey and Maethylle Bailey. This claim was submitted to the legislature for consideration on May 2, 1977.

The appropriations in this bill total \$282,503.80.

Your Committee on Ways and Means is in accord with the intent and purpose of H. B. No. 10 and recommends that it pass Second Reading and be placed on the calendar for Third Reading.

SCRep. 18 Ways and Means on H.B. No. 11

The purpose of this bill is to appropriate moneys out of the general revenues of the state to compensate persons pursuant to Chapter 351, Hawaii Revised Statutes, the Criminal Injuries Compensation Law.

This bill will compensate 162 victims, 33 attorneys, 37 doctors, hospitals and a funeral home. The total amount appropriated by this bill for these claims is \$223,847.13. These claims have all been reviewed by the criminal injuries compensation commission and recommended to the legislature for payment.

This bill is similar to H. B. No. 11, H.D. 2, which was fully heard and considered by the legislature during the 1977 regular session.

Your Committee on Ways and Means is in accord with the intent and purpose of H. B. No. 11 and recommends that it pass Second Reading and be placed on the calendar for Third Reading.

Signed by all members of the Committee.

SCRep. 19 Ways and Means on H.B. No. 12

The purpose of this bill is to lapse prior years appropriations which are no longer needed.

There remains from some prior appropriations unexpended and unencumbered balances which serve to obscure the true fund balance of the state general fund, especially in those instances where the purposes of the acts have been accomplished. By lapsing these balances, this bill will help clear the state's financial records.

This bill is similar to H. B. No. 12, H.D. 2, S.D. 1, C.D. 1 which was fully considered by the legislature during the regular session of 1977.

Your Committee on Ways and Means is in accord with the intent and purpose of H. B. No. 12 and recommends that it pass Second Reading and be placed on the calendar for Third Reading.

Signed by all members of the Committee.

SCRep. 20 Ways and Means on H.B. No. 13

The purpose of this bill is to transfer the responsibility for administering motor carrier safety functions and activities from the public utilities commission to the department of transportation and to provide the means for improved coordination of state and county highway safety programs.

This proposed transfer of motor carrier safety regulation resulted from the recommendations of the legislative auditor and is also in concert with the findings of the commission on organization of government.

This bill is similar to H. B. No. 1685, H. D. 2, S.D. 2, C.D. 1 which was fully heard and considered by the legislature during the 1977 regular session.

Your Committee on Ways and Means is in accord with the intent and purpose of H. B. No. 13 and recommends that it pass Second Reading and be placed on the calendar for Third Reading.

Signed by all members of the Committee.

SCRep. 21 Ways and Means on H.B. No. 14

The purpose of this bill is to establish the means of financing witness expenses required by county prosecutors and the public defender.

This bill amends existing law by providing that duly certified witness certificates for witnesses subpoenaed on behalf of the state by the public prosecutor, and on behalf of a defendant by the public defender shall be paid upon vouchers approved by the state director of finance and warrants drawn by the state comptroller. The amounts required for payment of these witness expenses are to be included in the department of budget

and finance's budget request for each fiscal biennium.

Appropriations totalling \$330,107 have been provided to implement this bill.

This bill is similar to H. B. No. 1693 which was fully heard and considered by the legislature during the regular session of 1977.

Your Committee on Ways and Means is in accord with the intent and purpose of H. B. No. 14 and recommends that it pass Second Reading and be placed on the calendar for Third Reading.

Signed by all members of the Committee.

SCRep. 22 Ways and Means on H.B. No. 15

The purpose of this bill is to complete the transfer of the statute revision and publication of laws program from the office of the revisor of statutes to the legislative reference bureau.

This will serve to clarify ambiguities relating to the administration of the office of the revisor of statutes by making it an integral part of the legislative reference bureau. Hopefully, greater efficiency and economy in the utilization of personnel and other resources will result from this transfer. Another result of this bill will be the rectification of an existing imbalance between the salaries paid to personnel in the office of the revisor of statutes and salaries paid for other comparable positions in the state.

The sum of \$20,000 is appropriated for the purpose of this bill. This bill is similar to H. B. 15, H.D. 1, S.D. 1, C.D. 1 which was fully considered by the legislature during the regular session of 1977.

Your Committee on Ways and Means is in accord with the intent and purpose of H. B. No. 15 and recommends that it pass Second Reading and be placed on the calendar for Third Reading.

Signed by all members of the Committee.

SCRep. 23 Ways and Means on H.B. No. 16

The purpose of this bill is to designate geographic areas within the state for the development of regional design plans and to appropriate funds towards this end.

It is hoped that this bill will provide for the development of urban and regional design plans for each county to facilitate quality design while protecting environmental, historic and other values in future development and construction, both public and private. The sum of \$125,000 is provided to implement this bill.

This bill is similar to H. B. 154, H.D. 2, S.D. 2, C.D. 1 which was fully heard and considered by the legislature during the regular session of 1977.

Your Committee on Ways and Means is in accord with the intent and purpose of H. B. No. 16 and recommends that it pass Second Reading and be placed on the calendar for Third Reading.
