Senator Kawasaki then rose on a point of personal privilege and stated as follows:

"Mr. President, I feel compelled to respond to some very scurrilous statements and attacks made on some of the very highest State positions, specifically, the Governor, the Lt. Governor and myself by Mayor Frank Fasi, impugning the integrity of the work of the duly constituted Senate Subcommittee investigating the Kohala Task Force.

Mr. President, at a luncheon gathering with a sizeable audience on Wednesday, Mayor Fasi, in his typical fashion, made some very derogatory remarks impugning the integrity of not only my Committee members and their work with the investigation of the Kohala Task Force, but also the character of the two highest government officials working in consonance with us to bring a better life to the people of this State.

Mr. Fasi, in his typical fashion, likened to the tactics of the late Joseph McCarthy, said that he has complete knowledge of a 'deal'...a 'deal', if you will, made between the Governor, the Lt. Governor and myself. The terms of the deal consist of the following: that in return for the support of Governor Ariyoshi for Lt. Governor Nelson Doi's campaign two years ago for the mayorship against Mr. Fasi, that Lt. Governor Doi would not run against the Governor for that position in 1978. Part of the deal included that as a very strong supporter, admirer and close friend of the Lt. Governor, that I, too, was asked and consented to dropping the investigation or the Kohala Task Force inquiry.

A committee, appointed by you and which I chaired, did investigate the improprieties as we saw it in the Kohala Task Force projects. Fasi said that I dropped that particular investigation as part of this deal to gain support for Lt. Governor Nelson Doi's race against him for mayor.

If Mr. Fasi only had informed himself properly, he would have found out that I not only did <u>not</u> drop that investigation, but that we came out with a very critical report outlining and specifying some of the improprieties we found in the Kohala Task Force projects.

As a matter of fact, this report was the basis for the present investigation being conducted by the County of Hawaii in its interest in this matter. I have been approached by Jim Dahlberg, the Chairman of the Council of the County of Hawaii who will be conducting this investigation, and by other members of that Council, and I have assured them of every cooperation, of every bit of information that my committee has uncovered; and that we will do everything possible to help them with the investigation, and that we will do this as a matter of public interest.

Fasi stated that as part of the deal that I was requested and again I consented to dropping my constant inquiry about the propriety of the existence of the Newspaper Preservation Act, which we enacted in 1973. He said that I had gone into a deal with the owners of the newspapers, the Honolulu Star Bulletin and the Advertiser, and that in return, that I would be assured of ample publicity and good support from the newspaper, the press, for Nelson Doi's campaign against him.

I would suggest to Mayor Fasi that he inquire with the owners of the Honolulu Star Bulletin and the Advertiser whether such a deal was made. I must say in compliment to the integrity, that although Mr. Chinn Ho, a majority stockholder in the Star Bulletin, and Mr. Giannellia who heads Gannett Corporation in Hawaii here, and to the credit of both Mr. Thurston Twigg-Smith and George Chaplin, who are personal friends of mine, they have never at any time, approached me for an agreement for them to cover Nelson Doi's campaign to his advantage against Fasi in return for my not saying anything about the newspaper monopoly situation.

As you recall, Mr. President, and for the edification of the minority members, on January 3rd of this year, prior to the session's starting, in a majority Senate caucus, I again approached the subject among my colleagues as to whether or not this was the time for us to repeal the Newspaper Preservation Act. Only recently, as you know,

the newspapers again raised advertising rates which will be passed on by the super markets to our consumers of this State. Again we discussed perhaps the need for the repeal of that Act in order to discourage wanton raising of advertising rates which affect the consumers of this State. So this answers Fasi's allegation that I am no longer interested in bringing about a cessation to the monopoly situation in the newspapers locally.

Now Mr. Fasi knows only too well, perhaps better than anybody else, that Lt. Governor Nelson Doi and myself would never enter into any kind of a deal whether with Mr. Fasi himself, with the Governor upstairs, with anyone else, to run or not to run for any particular position. Mr. Fasi knows better. But this does not faze him. This is just the beginning of Mr. Fasi's technique and campaign this year to use anyone, anybody's name, any situation to publicize what he considers this conspiracy against him throughout this State, to prevent him from running for Governor.

Now, ordinarily, I would just dismiss this as just another one of Fasi's antics, but when the integrity of high government officials with whom I serve and the integrity of the work of the Senate Subcommittee that investigated Kohala is involved and is impugned, then I think it is my responsibility to respond.

I agree with the Minority Leader who said in his Opening Day response to your Address, Mr. President, that the public has developed a rather jaundiced view about politicians and political bodies generally. The image is a little tarnished of late as a result of Watergate, the Bert Lance affair and the Kukui Plaza scandal, which was technically stymied through some technical procedures.

Now I think it is the responsibility of every one of us here as Senators, that anytime any person or any group of persons make an unjustified remark questioning the integrity of our work, or questioning the character of any one of us who are Senators, without justification, that we had better respond as a matter of public interest, again to restore public confidence in the people they elect.

Thank you, Mr. President."

At 11: 47 o'clock a.m., the Senate stood in recess subject to the call of the Chair.

The Senate reconvened at 11:55 o'clock a.m.
