Tuesday, January 31, 1978

The Senate of the Ninth Legislature of the State of Hawaii, Regular Session of 1978, convened at 11:30 o'clock a.m., with the Vice President in the Chair.

The Divine Blessing was invoked by Reverend James Anderson of Wesley United Methodist Church, after which the Roll was called showing all Senators present, with the exception of Senators Anderson, Soares and Ushijima, who were excused.

The Vice President announced that he had read and approved the Journal of the Ninth Day.
