The Senate of the Ninth Legislature of the State of Hawaii, Regular Session of 1978, convened at 11:30 o'clock a.m., with the President in the Chair.

The Divine Blessing was invoked by Reverend Kim On Chong, Retired Chaplain, MidPacific Institute, after which the Roll was called showing all Senators present, with the exception of Senators Anderson and F. Wong, who were excused.

The President announced that he had read and approved the Journal of the Eleventh Day.

Senator Nishimura then introduced to the members of the Senate 60 students from the second and third grades of Kahala Elementary School, accompanied by their teachers, Mrs. Leonora Kalua, Mrs. Janet Nohara, Mrs. Aiko Kobayashi and Miss Laurella Pang.
