NINETEENTH DAY

Monday, February 13, 1978

The Senate of the Ninth Legislature of the State of Hawaii, Regular Session of 1978, convened at 11:30 o'clock a.m., with the President in the Chair.

The Divine Blessing was invoked by Reverend Chiko Matsumoto of the Palolo Kanonji, after which the Roll was called showing all Senators present with the exception of Senator F. Wong, who was excused.

The President announced that he had read and approved the Journal of the Eighteenth Day.

At this time, the following introductions were made to the members of the Senate:
