## Friday, February 17, 1978

The Senate of the Ninth Legislature of the State of Hawaii, Regular Session of 1978, convened at 11:30 o'clock a.m., with the President in the Chair.

The Divine Blessing was invoked by Reverend Satoru Kawai of the Jodo Mission of Hawaii, after which the Roll was called showing all Senators present with the exception of Senators F. Wong and Yee, who were excused.

The President announced that he had read and approved the Journal of the Twenty-Second Day.

### ORDER OF THE DAY

### THIRD READING

Senate Bill No. 2200-78:

Senator R. Wong moved that S.B. No. 2200-78, having been read throughout, pass Third Reading, seconded by Senator Yamasaki.

Senator R. Wong then spoke for the passage of the measure as follows:

"Mr. President, I rise to speak in favor of this bill.

Senate Bill No. 2200-78 simplifies and more closely conforms the State Income Tax Law to the Federal Internal Revenue Code.

This bill represents the culmination of some three years of support and effort on the part of the Legislature. Working together with the Legislative Reference Bureau, the State Department of Taxation, the Tax Foundation of Hawaii and the Chamber of Commerce of Hawaii over the past three years, we have made tremendous progress. Major conformance legislation was passed last year--notably Act 47.

This has been a matter of great satisfaction to me as Chairman of the Ways and Means Committee because of the support and encouragement given towards greater conformance on the part of all the Committee members, both Democrat and Republican.

Senate Bill No. 2200-78 now before us raises the degree of conformance even further and makes the State Law more current with Federal Law, as of December 31, 1977. This bill is the direct result of Senate Concurrent Resolution No. 161, adopted last year, requesting the Legislative Reference Bureau and the Tax Department to review the State Income Tax Law and

to submit recommendations for closer Federal conformance.

Passage of this bill will further the efforts of the Legislature to reduce government red tape and make it easier for businesses to operate in Hawaii. Since 1975, Mr. President, under your leadership, this has been a major topic of concern on the part of the Senate, one shared by all members, majority and minority alike. This bill represents a major step forward in addressing this concern about the red tape problem.

I should note that this bill has the support of both the State and the private sector. In our hearing yesterday on this bill, favorable testimony was received from the Tax Foundation, the Chamber of Commerce, the National Federation of Independent Business and the real estate investment trust industry. No one spoke against the bill. This is one of the rare instances, Mr. President, of the enthusiastic unanimity on the part of all parties concerned with respect to a bill of such farreaching impact and great complexity.

The revenue impact of this bill is difficult to assess. The Tax Department has been working on this question. However, the consensus among the expert authorities is that it will result in a modest revenue gain to the State.

Mr. President, I would be remiss if I did not acknowledge the tremendous contribution made by the many individuals from government and from the private sector who worked many long hours in the preparation of this bill. Without their help, this bill would not have been possible. In particular, Mr. President, I would like to thank Lowell Kalapa from the Tax Foundation, Elliott Brilliant from the Chamber of Commerce, Dale Chikuami, formerly on the Ways and Means Staff, Tomotaru Ogai from the Tax Department, and especially Richard Kahle from the Legislative Reference Bureau.

Mr. President, I urge the members of the Senate to vote unanimously in favor of this bill.

Thank you very much, Mr. President."

Senator Kawasaki then stated as follows:

"Mr. President, I am going to vote in favor of this bill but with certain reservations.

I think a carte blanche approval of major changes in our State tax laws may be something we may regret in the future.

The only reason there was no particular vocal opposition to the enactment of this bill is because most people don't understand the voluminous nature of this bill.

I would like to have seen a change of our local State tax laws, section by section, and conformance with the Internal Revenue Code. I would not like to realize later that perhaps our State laws were a little more liberal, particularly with regard to the taxing of our middle income group of citizens. I think that today the middle income group foots the bill in this country and in our State.

The low income groups are given all kinds of benefits that we have enacted over the years, social legislation that benefitted them; and the wealthy doesn't matter as they have the financial means, but I think it is the middle income group of taxpayers that we should be particularly careful about.

Thank you, Mr. President."

At 11: 55 o'clock a.m., the Senate stood in recess subject to the call of the Chair.

The Senate reconvened at 11:57 o'clock a.m.

The motion was put by the Chair and carried, and S.B. No. 2200-78, entitled: "A BILL FOR AN ACT RE-LATING TO TAXATION", having been read throughout, passed Third Reading on the following showing of Ayes and Noes:

Ayes, 23. Noes, none. Excused, 2 (F. Wong and Yee).
