

TWENTY-FOURTH DAY

Tuesday, February 21, 1978

The Senate of the Ninth Legislature of the State of Hawaii, Regular Session of 1978, convened at 11:30 o'clock a.m., with the President in the Chair.

The Divine Blessing was invoked by Mr. John M. Ouvrier of the Worldwide Church of God, after which the Roll was called showing all Senators present, with the exception of Senators Hara, Saiki and R. Wong, who were excused.

The President announced that he had read and approved the Journal of the Twenty-Third Day.

The following introductions were made to the members of the Senate:

Senator King introduced 45 students from the American Government Class of the Hawaiian Mission Academy, accompanied by their teacher, Mr. Tetsu Hirayama.

Senator Yee introduced 20 seniors from St. Louis High School, accompanied by their teacher, Mr. Rod Santos.

Senator Anderson then introduced the student government officers of Kahuku High School and Hawaii Baptist Academy.

At 11:37 o'clock a.m., the Senate stood in recess subject to the call of the Chair.
