TWENTY-FIFTH DAY

Wednesday, February 22, 1978

The Senate of the Ninth Legislature of the State of Hawaii, Regular Session of 1978, convened at 11:30 o'clock a.m., with the President in the Chair.

The Divine Blessing was invoked by Bishop Palmer Spencer of the Church of Jesus Christ of Latterday Saints, Auwaiolimu Ward, after which the Roll was called showing all Senators present with the exception of Senator Taira, who was excused.

The President announced that he had read and approved the Journal of the Twenty-Fourth Day.

The following introductions were then made to the members of the Senate:

Senator F. Wong introduced Mr. Chu Ying Lun, Managing Director of Wing Wah Company of Hong Kong, dealers in diamonds and jade for over one hundred years.

By unanimous consent, S.R. No. 220 was referred to the Committee on Consumer Protection.

The President then introduced to the members of the Senate "Me-Too, De-Too", a robot from the University of Hawaii College of Engineering, who came to invite all to attend the Engineering Expo '78 at Holmes Hall on the University of Hawaii, Manoa Campus. Senator Takitani presented the robot with a certified copy of Senate Resolution No. 157 which had been adopted by the Senate on February 9, 1978.

The President also introduced Dr. Joel Fox, Faculty Exhibits Coordinator, and Curtis Fukushima and Steven Yabusaki, engineering students.

STANDING COMMITTEE REPORTS

Senator Yamasaki, for the Committee on Legislative Management, presented a report (Stand. Com. Rep. No. 90-78), informing the Senate that Governor's Message Nos. 120 to 135, Senate Resolution Nos. 216 to 220 and Standing Committee Report Nos. 91-78 to 95-78 have been printed and are ready for distribution.

On motion by Senator Yamasaki, seconded by Senator Henderson and carried, the report of the Committee was adopted.

Senator Chong, for the Committee on Health, presented a report (Stand. Com. Rep. No. 91-78), recommending that Senate Bill No. 1646-78 pass Second Reading and be referred to the Committee on Judiciary.

On motion by Senator Chong, seconded by Senator Takitani and carried, the report of the Committee was adopted and S.B. No. 1646-78, entitled: "A BILL FOR AN ACT RELATING TO VITAL RECORDS", passed Second Reading and was referred to the Committee on Judiciary.

Senator Chong, for the Committee on Health, presented a report (Stand. Com. Rep. No. 92-78), recommending that Senate Bill No. 1641-78, as amended in S.D. 1, pass Second Reading and be placed on the calendar for Third Reading.

On motion by Senator Chong, seconded by Senator Takitani and carried, the report of the Committee was adopted and S.B. No. 1641-78, S.D. 1, entitled: "A BILL FOR AN ACT RELATING TO HEALTH CARE FACILITIES IDENTIFICATION AND REGULATIONS GENERALLY", passed Second Reading and was placed on the calendar for Third Reading on Thursday, February 23, 1978.

In accordance with Article III, Section 16, of the Constitution of the State of Hawaii, the 24-hour notice was given on S.B. No. 1641-78, S.D. 1.

Senator Chong, for the Committee on Health, presented a report (Stand. Com. Rep. No. 93-78), recommending that Senate Bill No. 1724-78 pass Second Reading and be referred to the Committee on Ways and Means.

On motion by Senator Chong, seconded by Senator Takitani and carried, the report of the Committee was adopted and S.B. No. 1724-78, entitled: "A BILL FOR AN ACT RELATING TO SUPPORT OF MENTAL HEALTH-RELATED PROGRAMS", passed Second Reading and was referred to the Committee on Ways and Means.

Senator Yim, for the Committee on Energy/Natural Resources, presented a report (Stand. Com. Rep. No. 94-78), recommending that Senate Concurrent Resolution No. 28, as amended in S.D. 1, be adopted.

Senator Yim moved that the report of the Committee be adopted and that S.C.R. No. 28, S.D. 1, be adopted, seconded by Senator Takitani.

Senator Leopold then spoke for the motion as follows:

"Mr. President, I have been informed this week by the Assistant to the President for Domestic Affairs and Policy that there has been no final decision not to proceed with regional storage of emergency oil reserves for both the New England states and Hawaii.

The recent decision announced by the Secretary of the Department of Energy that the 1979 Federal budget will not include funds for emergency oil reserve in Hawaii, in no way forecloses the option of the President's approval of a supplemental budget item to include such storage.

In other words, the Carter Administration is still open to further efforts on the part of the State of Hawaii to provide emergency oil reserves for our State. In this regard this resolution may be helpful.

Thank you, Mr. President."

The motion was put by the Chair

and carried, and the report of the Committee was adopted and S.C.R. No. 28, S.D. 1, entitled: "SENATE CONCURRENT RESOLUTION REQUESTING PRESIDENT CARTER AND THE CONGRESS TO PROVIDE HAWAII ITS RIGHTFUL SHARE OF THE U.S. DEPARTMENT OF ENERGY'S PROPOSED BUDGET FOR THE STRATEGIC PETROLEUM RESERVE", was adopted.

Senator Yim, for the Committee on Energy/Natural Resources, presented a report (Stand. Com. Rep. No. 95-78), recommending that Senate Resolution No. 92, as amended in S.D. 1, be adopted.

On motion by Senator Yim, seconded by Senator Takitani and carried, the report of the Committee was adopted and S.R. No. 92, S.D. 1, entitled: "SENATE RESOLUTION REQUESTING PRESIDENT CARTER AND THE CONGRESS TO PROVIDE HAWAII ITS RIGHTFUL SHARE OF THE U.S. DEPARTMENT OF ENERGY'S PROPOSED BUDGET FOR THE STRATEGIC PETROLEUM RESERVE", was adopted.

At 11:55 o'clock a.m., the Senate stood in recess subject to the call of the Chair to allow the members of the Kanikapila O Pa'ahao to entertain the members of the Senate.

The Senate reconvened at 12:04 o'clock p.m.
