TWENTY-SEVENTH DAY

Friday, February 24, 1978

The Senate of the Ninth Legislature of the State of Hawaii, Regular Session of 1978, convened at 10:00 o'clock a.m., with the President in the Chair.

The Divine Blessing was invoked by Bishop Glen Bendixen of the Church of Jesus Christ of Latter-day Saints, Makiki Ward, after which the Roll was called showing all Senators present with the exception of Senator Soares, who was excused.

The President announced that he had read and approved the Journal of the Twenty-Sixth Day.

The following introductions were then made to the members of the Senate:

Senator Yee introduced a group of twenty Seniors from St. Louis High School with their teacher, Mr. Rod Santos.

Senator Kuroda introduced 80 students from the fifth grade at Iroquois Point Elementary School, with their teachers, Mrs. Cathy Ong, Mrs. Sue Arsiga, Mr. Jack Rathburn and Miss Judy Hamamoto, and parents, Mrs. Hutchison, Mrs. McCleer, Mrs. Harper and Mr. and Mrs. Payne.

Senator Anderson then introduced 41 senior citizens from the Hui Lea Lea O'Hawaii Kai group.

Senator O'Connor introduced a delegation from Kaiser High School together with their principal Mrs. Margaret Oda, who are delivering a petition to the members of the Senate from the Seventh Senatorial District.

Senator Kawasaki then stated as follows:

"Mr. President, I would like to comment on this resolution.

I am particularly appreciative of the great impact and the contribution the Moiliili Japanese School and its founders have made to this State of ours. There is one subject taught in language schools, Japanese language schools, which is the subject of ethics, in Japanese called 'shushin' and I think the impact of this particular item in their curriculum has had a very salutory effect on the State.

It is reflected in the fact that most of the graduates of the Japanese language schools are not part of the criminal statistics that appall us. They are not, generally speaking, part of the statistics involving great welfare costs to welfare recipients.

I would like very much to see the public schools incorporate into their curriculum, the basic course of ethics as it is practiced by the Japanese language schools, but I am appreciative, as a member of this Senate, of the contributions made, not only by the Moiliili Japanese School, but by all language schools... Chinese language schools, the Korean language schools, the Japanese language schools.

I think this Body should support with great energy and encouragement for the continuance of schools of this nature, after the regular public school hours, to keep our youngsters busy, but more importantly, to help develop their character in subjects like ethics.

Thank you, Mr. President."
