TWENTY-EIGHTH DAY

Monday, February 27, 1978

The Senate of the Ninth Legislature of the State of Hawaii, Regular Session of 1978, convened at 11: 30 o'clock a.m., with the President in the Chair.

The Divine Blessing was invoked by Dr. Edmond Walker, Hawaii Baptist Convention, after which the Roll was called showing all Senators present.

"It is the intent of your Committee on Health that no unit of state or county government, in the case of an emergency, shall deny ambulance service to any person unable to pay, or make any inquiry regarding ability to pay prior to the rendering of ambulance service to the person in need thereof. It is the expressed intent of the committee that this principle be closely adhered to in all emergency situations."

Senator Kawasaki then inquired: "Why was the bill introduced by request?"

Senator Chong replied that it was introduced by request for the Department of Health. Senator Anderson then rose to state:

"Mr. President, I'm in favor of the bill and I see no objections to its passage, but, it's too bad it doesn't include hospitals because we may rush someone there someday and that person will be dying in the admitting room while they get the information before admittance."

The motion was put by the Chair and carried, and S.B. No. 1752-78, entitled: "A BILL FOR AN ACT RELATING TO FREE EMERGENCY AMBULANCE SERVICE", having been read throughout, passed Third Reading on the following showing of Ayes and Noes:
