Thursday, March 2, 1978

The Divine Blessing was invoked by Reverend Joe Sanders of the Nuuanu Baptist Church, after which the Roll was called showing all Senators present.

The President announced that he had read and approved the Journal of the Thirtieth Day.

SENATE CONCURRENT RESOLUTIONS
